I am directed to refer to your office letter No. MKTG/MOFPI/01/2017 dated the 6<sup>th</sup> April, 2018 on the above subject and to say that the proposal of the Board was recommended and forwarded to the Ministry of Food Processing Industry vide this Department's OM dated the 4<sup>th</sup> May, 2018 to consider designation of Spices Parks as food parks for availing affordable Credit from NABARD and grant from the Ministry of Food Processing Industries.

In this regard, Ministry of Food Processing Industries has informed that the Spices Park at Guntur Andhra Pradesh has already been designated as Food Park on the recommendation of the State Government.
