The International Pepper Community (IPC), an intergovernmental organization under the auspices of the United Nations Economic and Social Commission for Asia and the Pacific (UN-ESCAP), has invited nominations for IPC Awards-2021 from India. There are two categories for the IPC Awards for exporters:

- 1) Excellence in Export of Value-Added Pepper Products Year 2021
- 2) Excellence in Innovative Pepper Products Manufactures Year 2021

- Excellence in Export of Value-added Pepper and Pepper products
- Excellence in Manufacture of Innovative Product / Products of Pepper

Introduction

The International Pepper Community, Jakarta, Indonesia, under the UN-ESCAP has instituted Export Award to honour the exporter of value-added and innovative products of pepper who have excelled in their exports in various pepper products by granting Awards every year.

Product Categories:

Awards will be given for the following categories.

- 1) Excellence in Export of Value-added Pepper and Pepper products
- 2) Excellence in Manufacture of Innovative Product / Products of Pepper

Period of exports covered for the awards

- 1. FOB value of export performance of all value-added pepper and pepper products less imports of raw material, if any, during the calendar year 2021 For Excellence in Export of Value-added Pepper and Pepper products category.
- 2. Total value of innovative products of pepper produced and sold both within the country and abroad during the calendar year 2021 For Excellence in Manufacture of Innovative Product / Products of Pepper category.

Criteria for selecting Winners:

- 1. Exporter / Manufacturer should be from the IPC member countries (Brazil, India, Indonesia, Malaysia, Sri Lanka, Vietnam and Papua New Guinea).
- 2. Net Foreign Exchange earned from the exports of value-added pepper and pepper products shall be more than USD 10'000 or 900Kgs. The Net Foreign Exchange earned will be arrived at after deducting total CIF value of pepper/raw material imported from the FOB value of the value-added pepper and pepper products exported during the calendar year 2021.

Export performance of value-added pepper and pepper products mentioned in the Schedule will only be considered. Import of pepper in any form should be mentioned in the statement. Export performance of pepper in whole & bulk form after simple cleaning & grading, and curry powders will not be included under this category.

Value-added Pepper: Export performance of pepper crushed, pepper powder, milled pepper etc., and other value-added products of pepper, in sterilized, certified organic (Certificates in proof of organic farms/units should be furnished), dehydrated, frozen, freeze dried, in brine, candy, paste, flake, granules etc. and any other value-added forms including pepper oils & oleoresins, Pepper in consumer packs (up to 2.5 kgs), ground pepper (Ground form includes fine powders and crushed pepper in various mesh sizes) will be accounted under this category.

Application Guidelines for IPC Awards

3. Award for Excellence in Manufacture of Innovative Product (s) of Pepper.

Total sale value of newly developed product(s) of pepper, which is innovative in nature and marketed both within the country and abroad during the year 2021 will be considered under this category.

Innovative product(s) of pepper of any kind / nature developed by any institution, agency, company, which is new to the market and currently none existing in the country will be considered under this category. The minimum value or volume of sale of such products (Domestic & Export) shall be more than USD 2500 or 225 Kg accordingly, the application will be considered for the efforts and successful introduction and sale of the product in the market under this category.

Selection Process

- 1. The applications along with relevant information received from the applicants will be screened by respective country's Liaison Officer.
- 2. After the evaluation, the short-listed applications (minimum two) will be sent to the Executive Director of the IPC along with suitable covering letter and recommendation, for evaluation as per the norms stipulated and finalize.
- 3. The selection of the Award winners will be communicated to the concerned under intimation to the LO for organizing an event for distribution in the respective country.

Instructions for submitting the applications

- 1. Application in the prescribed form along with relevant documents should reach the respective Liaison Officer, prior to 50th HOD Meeting. Applications received late will not be considered.
- 2. The envelop should be super scribed "Export Award 2021"
- 3. Application should have all relevant information and should be in the prescribed form. No column should be kept blank; if a column is not applicable, the same must be written as 'Not Applicable'
- 4. The company may sumit application for more than one category (both Value-added / Innovative Product).
- 5. The export / import statements in the application should invariably be certified by the Bankers and Chartered Accountant.
- 6. Application should be accompanied by all relevant documents.
- 7. Application not completed or with inadequate requirements shall not be considered.
- 8. A passport size of the CEO / Managing Director should be sent along with the brief write up of the company.

Major Benefits:

- 1. A profile of the award winner will be placed in the IPC website for one year.
- 2. Opportunity to participate in the IPC Session and other Meetings of the IPC
- 3. Opportunity to network with other Award winners and exporters/ traders/ manufacturers/ farmers of pepper and other spices
- 4. A citation and framed IPC Award Certificate will be presented
