^{*} In the case of establishment of ETP system, the interested agencies/ firm may also submit their willingness for the same. The terms and condition for establishing the ETP system will be discussed and finalized through a pre-bid meeting. The selected Agency will be allowed to establish the ETP system as a common facility for the use of the Spice processing units established in the park. The user fee will be fixed by the Board in consultation with Agency and the Users is in the park. For establishing the system 1000 to 2000 square meter of land will be provided to the Agency on a long lease up to 15 years

Terms and conditions for renting the Built-up area:

- 1. The facilities will be rented out in "As is where is" Condition
- 2. The facilities will be rented out for 5 years from the date of handing over, which can be extended for a further period on a mutually agreed term.
- 3. The rent will be increased @ 5% per annum.
- 4. Spices Board will provide water and electricity to the facilities on payment on prorate basis.
- 5. The facilities will be rented out to the party who has quoted highest rent per month as well as meeting other terms and conditions of the Board.
- 6. The highest bidder shall execute an Agreement with the Board within 15 days of the receipt of the offer letter from the Board.
- 7. The highest bidder shall pay an interest free Security Deposit equivalent to three months' rent in the form of Demand Draft in the name of Secretary, Spices Board or online bank transfer to Board's Receipt Account. The security deposit without interest would be returned at the time of handing over the

- facilities to the Board. The security deposit will have to be remitted along with the agreement.
- 8. The highest bidder shall take possession of the appropriate Space/Facilities Available for Leasing / Renting within 15 days from the date of agreement and after the receipt of Security Deposit. If the possession is not taken within 15 days from the date of agreement, it will be treated it as breach of the tender conditions and the Board has the right to lease the facilities to other eligible firm/agency.
- 9. The monthly rent with 18% GST shall be paid to Spices Board on or before 5th of every succeeding month.
- 10. The facilities shall not be sub-let to any other firms.
- 11. The Board reserves the right to reject / cancel any or all bids without assigning any reasons thereof.
- 12. The Interested parties may visit the facilities on Monday to Friday from 9 am to 5.30 pm. They may contact the Officer In Charge, Spices Park whose contact details are given below
- 13. The Board will terminate the lease if the facilities are not utilized continuously for more than 3 months or nonpayment of the monthly rent in time
