Tender not in the prescribed format and without EMD will be rejected. Successful bidder should remit the bid amount in full and clear the material from the premises on or before 16<sup>th</sup> May 2016. Spices Board will not be responsible for the security of the vehicle lying uncleared at the office premises beyond 16<sup>th</sup> May 2016. It is the responsibility of the bidder to change the ownership of the vehicle within one month from the date of delivery. EMD will be returned to the successful bidder only after producing proof of changing ownership of the vehicle. Spices Board reserves the right to accept or reject any or all the proposals without assigning any reason.
