Bids invited for renting out the Canteen building (Ground Floor) in Spices Park.
Raebarely, Uttar Pradesh

Spices Board, Ministry of Commerce & Industry, Government of India has established a Spice Park in Datauli village, Raebarely of Raebarely District of Uttar Pradesh. Spices Board proposes to rent out the Canteen building having an area of 800 sq ft with basic amenities like electricity, water and toilet (ground floor) as per the following terms and conditions.

Terms and conditions for renting the canteen building:

1. The facilities will be rented out in "As is where is" Condition.
2. The Canteen will be rented out for three years from the date of handing over.
3. The rent will be increased @ 5% per annum.
4. Spices Board will provide water and electricity to the facilities on payment on prorated basis.
5. The facilities will be rented out to the party who has quoted highest rent per month as well as meeting other terms and conditions of the Board.
6. The highest bidder shall execute an Agreement with the Board within 15 days of the receipt of the offer letter from the Board.
7. The highest bidder shall pay an interest free Security Deposit equivalent to three months' rent through online bank transfer to Board's Receipt Account. The security deposit without interest would be returned at the time of handing over the facilities to the Board. The security deposit will have to be remitted along with the agreement.
8. The highest bidder shall take possession of the canteen 15 days from the date of agreement and after the receipt of Security Deposit. If the possession is not taken within 15 days from the date of agreement, it will be treated as breach of the tender conditions and the Board has the right to lease the facilities to other eligible firm/agency.
9. The bidder shall take FSSAI license for running the canteen after taking over the building but before the commencement of the service of the canteen supplying refreshments/food/tea/coffee etc.
10. The monthly rent with 18% GST shall be paid to Spices Board on or before 5th of every succeeding month.

11. The facilities shall not be sub-let to any other firms.
12. The premises should be used only as canteen and should not be used for conducting other business activities or as a residence.
13. The Board reserves the right to reject / cancel any or all bids without assigning any reasons thereof.
14. The Interested persons/firms may visit the canteen building (ground floor) on Monday to Friday from 9 am to 5.30 pm. They may contact the the Officer In Charge, Spices Park in the following address before the visit.

15. The Board will terminate the lease if the facilities are not utilized continuously for more than 3 months or nonpayment of the monthly rent in time.

17. EMD is not applicable to submit the Bid. However, the bidders shall submit the Bid Security Declaration in the prescribed for as given in Annex-II.

The bid shall be sent in a sealed cover superscribed as "Bid for canteen Building at Spice Park, Raebarely" addressed to the "Officer in charge, Spices Park, Datauli Village, Harchandapur P.O. Raebarely, Uttar Pradesh-229303" so as to reach on or before 2 pm on 26.12.2022.
