Sub: Sample Drawn Certificate for Cumin and Chillies Whole –List of Authorized signatories -reg.

With reference to the Circulars cited above, the registered exporters of spices and spice products have been provided with the facility for exporting the consignments of Cumin Seed Whole and Chillies Whole to selected countries (*countries list is provided in the circular under reference 1*) with a Sample Drawn Certificate (SDC) in lieu of the Sample Analytical Report issued by the Board's Quality Evaluation Laboratory. Under this facility, exporters can stuff the material to container (s) after the samples have been drawn by the designated surveyors of the Board, without waiting for the results of the sample analysis.

In this regard, the list of the officials of the Board, who are nominated as authorised personnel to sign the Sample Drawn Certificate (SDC) in their respective region is furnished below, which will be effective from the date of this Circular, except in the region mentioned under SI.No. 10 & 12, which will be effective only from 01.02.2022.
