Buyer Seller Meet for Black Pepper in Araku Valley, ASR District, Andhra Pradesh

Spices Board organised a Buyer Seller Meet for Black Pepper on 29 November 2022 in Araku Valley, ASR district, Andhra Pradesh under the project 'Strengthening spice value chain in India and improving market access through capacity building and innovative interventions' implemented by the Board in collaboration with Standards and Trade Development Facility (STDF) under World Trade Organisation (WTO) and Food and Agriculture Organisation (FAO). The buyer seller meet aimed at creating a platform for better market access to the farmers by linking farmers/FPOs with buyers/exporters. More than 285 participants including farmers, FPOs, traders and exporters from various parts of the country attended the programme. Representatives from local bodies, officials from FAOIN, NDC, IDH, Spices Board, line departments and others also attended the programme.

Smt. Jallipalli Subhadra, Hon'ble Chairperson, Zilla Parishad attended the programme and in her address she explained the life of tribal farmers, their livelihood, climatic and geographical conditions of the area, cultivation methods of crops which are grown in tribal areas especially, coffee, pepper, turmeric, ginger, tamarind, and long pepper. She opined, "Even though tribal farmers are growing most of the crops naturally, they are not getting better marketing facilities and better price for their produce". She requested Spices Board to conduct more such buyer seller meets which are very helpful to the farmers.

Shri Chetti Palguna, Hon'ble MLA, Araku Constituency in his address mentioned the post-harvest improvement support extended by Spices Board to the farmers through supply of equipment such as pepper threshers, tarpaulin/ silpaulin sheets, and aluminium ladders. He also requested Spices Board for organic certification of pepper and turmeric crops and expansion of the Board's services for the development of tribal farmers.

Shri Sathaka Bulli Babu, Hon'ble Chairman, TRICOR, Andhra Pradesh appreciated the efforts taken by Spices Board for conducting the buyer seller meet for black pepper in Araku Valley and he requested the Board to provide training to the farmers on post-harvest machinery manufacturing, so that the local farmers make the machinery locally to process their produce. He highlighted the need for organic certification for the naturally grown produces in the region. He also assured necessary support to the exporters for establishment of Piperin and Curcumin extraction units in ASR district.

Smt. Susmitha Rani, Sarpanch, Padmapuram Panchayat, Araku Valley appreciated Spices Board for conducting the buyer seller meet and informed that farmers in Araku valley are growing pepper and coffee naturally without adding any chemicals. She said that, buyers could purchase directly from farmers to get better price for their produce. She also requested all the farmers to utilize the opportunity to get better market access.

Shri Sumit Kumar IAS, Collector and District Magistrate in his address, informed that the farmers are not aware of the quality of their produce, so buyers/exporters should give necessary support to the farmers to get better quality and good quantity of their produce. "Buyers should purchase not only the best quality produce but also other leftover produce from the farmers", he added. He also told the farmers to check the quality of pepper being produced before selling it for getting better price.

Shri B. Venkateson, Director (Development), Spices Board explained about the STDF project which is being implemented by the Board with the support of FAO and WTO. He said that the BSM is one of the parts under this project.

Shri Vinay Singh, Project Manager, FAO in his speech said that though India is the largest producer of spices, the export of spices

from India is subjected to rejection by countries which are sensitive to quality issues and the project is being piloted in Araku Valley and Paderu to build the capacity of farmers and other stakeholders across the value chain to improve the quality of spices. He also informed that there is a need for connecting farmers with exporters/buyers, so that farmers can utilize the benefit of better price realization. He also appreciated the dedication with which Spices Board, Paderu is implementing the project.

Dr Joji Mathew, Deputy Director (Development), Spices Board while welcoming the participants explained the role of Spices

Board in export development of spices in India. He also informed that Spices Board is implementing the project 'Strengthening spice value chain in India and improving market access through capacity building and innovative interventions' in Araku Valley and Paderu areas with an aim to ensure export of safe and high-quality spices from India to overseas markets and also to address sanitary and phytosanitary issues which are faced in field level.

"Spice Board is conducting a BSM for black pepper in Araku Valley due to the uniqueness of black pepper which is grown naturally by the farmers of Araku Valley. And this programme is being conducted to create a platform for better market access and linking farmers/FPOs directly to the buyers/exporters", Dr Joji Mathew added. He further informed that Spices Board has collaborated with the Quality Council of India (QCI), United Nations Development Programme (UNDP), etc. for implementing schemes especially, for the development of tribal farmers.

The introductory session was followed by a technical session and Smt. Kalyani Boddu, Senior Field Officer, Spices Board, Paderu welcomed all the participants to the technical session. During the interactive session, farmers/FPO representatives informed the availability of various spices whereas the exporters/buyers informed their requirement for pepper and other spices. All farmers/FPOs requested to purchase the produce directly from them by avoiding middlemen and also requested training from the buyers regarding the quality they require.

Shri B. Venkateson, Director (Development), Spices Board interacted with exporters/buyers and assured that Spices Board will support for Organic Certification. Dr Joji Mathew, Deputy Director (Development), Spices Board requested the exporters and buyers to procure the produce directly from the farmers, then only the BSM will serve its purpose and farmers will get the benefit out of this programme.

After the interactive session, farmers, FPOs and buyers/exporters appreciated the service of Spices Board in Paderu and Araku in addressing the quality issues and requested for the expansion of Spices Board's services in Paderu tribal agency areas. The meeting concluded with the vote of thanks by Shri Nithin Joe, Deputy Director, Spices Board. As part of the BSM, a visit to farmers' fields at Doravalasa and Tudumu hamlets of Chinalabudu village was organised on 30 November 2022.

Director's Message

Export Oriented Production Programmes and International Collaborative Projects of Spices Board for Spices Development and Export

Agriculture is an essential component for the livelihood and food security of rural households in India. Over 60 per cent of India's population is directly or indirectly involved in farming operations. Most farmers operate small-scale farms. The Government of India is making continuous efforts to improve the living standards of the farming community through many of its organizations including Spices Board and other line departments, agencies, etc. Given India's varied agro-climatic zones, agriculture has a great potential to boost development in rural areas, expand exports and reduce poverty. However, much more needs to be done to scale up the standards of practices in farming, production and post-harvest to meet the stringent food safety standards and expand market access.

In this context, Spices Board, with its limited mandate of post-harvest improvement and export promotion of 52 spices and production and research of Small and Large Cardamom, is implementing various schemes under its Export-Oriented Production Programmes to support the spices farmers across India.

Export-oriented Production Programmes for Spices

Spices Board implements 21 programmes for the post-harvest improvement, keeping in mind the phytosanitary requirements for spices like turmeric, ginger, black pepper, chilli, nutmeg, clove and seed spices viz., cumin, fennel, coriander, etc., and production, processing and quality improvements of Small and Large Cardamom. Spices Board has implemented

programmes with a financial assistance of Rs 23.5 crores towards the above objective which benefited 35,503 farmers across India during 2021-22.

The important programmes implemented include distribution of spices processing machinery like threshers, washers, driers, turmeric boilers and polishers; HDPE sheets; organic certification and organic cultivation programmes for various spices and assistance for replanting, quality seedling multiplication, irrigation and land development programmes for Small and Large Cardamom at a financial assistance of 50 per cent for General category and 75 per cent for SC/ST farmers respectively.

A special programme of Quality Gap Bridging Group (QGBG) for FPOs and farmers' groups with components like post-harvest processing machinery and demonstration plots was also implemented with 90 per cent financial assistance. All these programmes are aimed at sustainable production of quality spices that enables exporters to source quality spices for export. Quality Improvement Training Programmes (QITP) were conducted across the nation for various spices by incurring Rs 17.2 lakhs and trained 8695 spice farmers during 2021-22. All the above programmes together benefited 6265 SC/ST farmers with a financial assistance of 8.63 crores out of the total Rs 23.5 crores.

Spices Board is also involved in several Sanitary and Phytosanitary (SPS) related activities in spices. The Board has organised capacity building training programmes in collaboration with various national and international bodies and made interventions to improve the existing farming practices with Good Agricultural Practices (GAP), better processing, and marketing of spices. These measures are taken up with the aim to produce IPM quality spices with SPS measures to

facilitate export of spices in the long run. The international collaborative projects/associations undertaken are as follows:

1. The pilot project: “Strengthening spice value chain in India and improving market access through capacity building and innovative interventions”.

This is an international collaborative pilot project started in 2020 with the Standards and Trade Development Facility, Geneva; Food and Agriculture Organization-India and Spices Board as the local implementation agency. The STDF pilot project is still under implementation by Spices Board and will be completed by 2023 with a total cost of Rs 7.3 crores with a split up of Rs 4.16 crores from STDF, Geneva, Switzerland, Rs 0.82 crore from FAO and Rs 2.32 crores from the Ministry of Commerce and Industry, Government of India through Spices Board.

The overall objective of the project is to expand the export of safe and high-quality spices from India. This will also contribute to improved food safety and consumer health. This project is further expected to boost the income of small-scale farmers, empower women and marginalized (tribal) communities, and support efforts to reduce poverty (Sustainable Development Goal (SDG) 1) and hunger (SDG 2) in the selected project areas in India. The project also aims to build the capacity of stakeholders in the spice value chain to improve the safety and quality of three seed spices (cumin, fennel and coriander) and black pepper to increase market access with the involvement of 1200 farmers in 12 villages. The project is mainly focused at four selected areas viz., Paderu in Andhra Pradesh, Mehsana district of Gujarat, Jodhpur district of Rajasthan and Guna district of Madhya Pradesh, to implement improved food safety management systems and international food safety standards (Codex) in order to expand production, improve food safety and quality, promote value addition and boost exports.

This project also involves collaboration with agriculture departments, agriculture universities, Spice Research Stations, as well as other government entities. Providing training and advisory services to farmers will ensure that the activities will continue even after the project period. The capacity building of field level extension officers and all stakeholders involved in

the spice supply chain will ensure that the farmers/stakeholders will continue to receive training and guidance on how to produce safe and quality spices even after the completion of the project. Training modules and Training of Trainers (TOT) programmes will ensure the continuity of training on SPS standards and quality and safety management after the end of the project. The task of trainers is made easier by making available the training materials, manuals and leaflets developed while implementing project for public access through the Board's website. Thus, the knowledge imparted will be continuously made available and disseminated. This project strengthens the infrastructure by providing support to build a network of labs for testing and linking the same to farmers which will function even after the completion of the project. It is being planned to associate the INDGAP certification programme to certify the growers' groups under the STDF project for traceability and production of quality spices suitable for exports and further linkage with prospective exporters for direct procurement.

2. National Sustainability Spice Programme (NSSP), is an international collaborative spice project implemented by the World Spice Organization with the collaborative partners viz., GIZ and IDH. Spices Board is also supporting NSSP programme as a collaborative partner in the technical side in capacity building and sustainability programmes for the spice stakeholders. The programme provides a platform for the stakeholders of the spice industry to make a commitment to source products sustainably and to make a positive impact in their value chains.

In addition to the above-mentioned activities, Spices Board is also involved in mandatory quality testing of export consignments of spices through its network of NABL accredited Quality Evaluation Laboratories and by ensuring facilities for primary processing and value addition through the eight Spices Parks established across India, along with various other export development and promotional programmes aimed at achieving an ambitious export target of US\$ 10 billion by 2027. Spices Board is open to explore all possible avenues to achieve the said target by working jointly with the various associations of spice stakeholders in India.



Spices Board in Gulfood Manufacturing 2022

Spices Board India participated in the Gulfood Manufacturing 2022 organised and conducted at the World Trade Centre Dubai, United Arab Emirates during 08 – 10 November 2022. Gulfood Manufacturing is one of the largest food and beverage processing and packaging shows in the Middle East, Asia and Africa. Approximately, 1300 food and beverages manufacturers from over 55 countries participated in the expo to showcase the latest solutions in ingredients, processing, packaging, supply chain and control and automation. The expo also presented a three-day food tech summit with 100+ speakers from across the globe.

The Indian pavilion was inaugurated by Shri Sunjay Sudhir, Ambassador of India to UAE. Shri B. Venkateson, Director (Development) and Smt. Vijeeshna V., Assistant Director, Spices Board represented the Board in the event and welcomed the Ambassador to the Board's pavilion. Dr Aman Puri, Consul General of India visited Spices Board's pavilion and interacted with the Board's officials as well as the exporters and appreciated the participation of Indian Spice Exporters in Spices Board pavilion.

First day of the event focussed on global food challenges in Africa and South Asia. Latest developments in food inflation and tackling rising energy costs and supply chain blockages were also discussed. It also explored the enhanced opportunities for combating food crisis in saturated markets like South Asia and why investment opportunities in Africa are the gateway to food security. The second day of the food summit focussed on sustainable practices, exploring how sustainability can be the catalyst for progress during an era of eroding food security. Visitors at Spices Board's stall enquired about quality Indian spices and spices that are produced in the country in any form.

Spices Board in 41st India International Trade Fair

Spices Board participated in the 41st India International Trade Fair – an exhibition organised at Pragati Maidan, New Delhi, during 14 – 27 November 2022. The 41st India International Trade Fair exhibition was inaugurated by Shri Piyush Goyal, Minister, of Commerce & Industry, Consumer Affairs, Food & Public Distribution, and Textiles, Government of India. Spices Plant of ITC Limited at Spices Park, Guntur Inaugurated

Shri Y. S. Jagan Mohan Reddy, Hon'ble Chief Minister, Government of Andhra Pradesh inaugurated the internationally benchmarked spices plant of Indian multi-business conglomerate, ITC Limited at Spices Park, Guntur, Andhra Pradesh on 11 November 2022. The ITC Limited has a century-old association with Andhra Pradesh and has been expanding its presence across the three key sectors of the state's economy – agriculture, manufacturing, and services. The newly inaugurated spices plant will focus on exports to Europe, USA, Canada, Australia, and China. Mr Sanjiv Puri, Chairman, ITC Limited and other eminent dignitaries were present on the occasion.



The Minister during the inaugural function congratulated ITC and said that ITC's global spice processing facility unit will benefit thousands of farmers. The spices processing plant possesses a capacity of 20,000 metric tonnes of spices that can be processed annually and will provide facilities for cleaning, grading, grinding, steam sterilization, destemming and packing of 15 varieties of spices that grow in the region. "The second phase of the plant will complete in the next sixteen months and then it will become the largest spices processing unit in Asia", the Minister opined. He added that Andhra Pradesh has been at the top among other Indian states in terms of Ease of Doing Business (EoDB). The Minister also explained the YSRCP government decision to establish 10,668 Rythu Bharosa Kendras (RBKs) across the state which has brought revolutionary changes in the agriculture sector. Shri Y.S. Jagan Mohan Reddy, Hon'ble Chief Minister, Government of Andhra Pradesh assured all possible support from the state government.

Commenting on the launch of this unit in Spices Park, Guntur, Shri Sanjiv Puri, Chairman, ITC Limited said, "Inspired by the Hon'ble Chief Minister's vision to usher in rapid and inclusive socio-economic development of Andhra Pradesh, I am delighted to announce the launch of our world-class spices factory in Guntur that promises to strengthen the State's position as a global hub for spices. The future-ready, export-oriented facility is an iconic Make-in-India industrial unit that will offer the finest quality of spices to the world conforming to global food safety export norms, whilst anchoring local agri-value chains. The unit will also be a flagbearer of sustainability and inclusion owing to its 360-degree initiatives that will contribute to raising incomes, foster women empowerment and support large-scale livelihoods whilst promoting extensive use of renewable energy".

The unit will source spices which shall influence 5000+ farmers' families, will also generate a direct employment for around 500 people and indirect employment for over 2000 across the value chain. The plant will be equipped with end-to-end processing needs, including storage, cleaning, processing, sterilization, packing, and quality testing. The infrastructure is compliant with Global Food Safety Export Guidelines. The newly opened processing unit will manufacture and export a wide range of products and anchor inclusive spices value chains to empower thousands of Indian farmers.

Know Your GI Spice Harmal Chilli



Belonging to the family of *Capsicum Annum* L, Harmal Chilli is a famous variety of chilli grown in the Harmal village in Pernem Taluka located in North district of Goa. This chilli is known for its spicy taste compared to other Goan chilli varieties and high colour value. The Harmal chillies are reddish-brownish in colour with a short length. It is medium to highly pungent in taste and gives a strong taste and colour when added to food preparations and recipes in a small quantity. This chilli has a good shelf life and can be stored for a longer duration. These chillies grown on lateritic soil with pH value of 5.5 to 6.5, contains rich minerals such as iron, manganese and copper. Chilli fruits contain large quantity of seeds and hence give good quantity of chilli powder and support its characteristics of colour and pungency. Harmal chilli plant is a sub-herb. Harmal chillies are grown only for dry usage purpose either by making powder as a whole or mixed and blended with other masalas in different proportions to suit different Goan cuisine. Harmal chillies have got the colour value of 48.8 (ASTA) with 0.18 % capsaicin value and pungency of 28,200 SHU.
