The bidder must be a CERT-IN empaneled information security auditing organization. Documents required to be submitted to prove eligibility criteria : copy of valid CERT-IN Certificate

Scope of Work and Terms and Conditions

- Service Provider shall possess the technical expertise, ability, experience, resources and infrastructure to render the service.
- The successful bidder shall accept the work order within 15 days from the date of issue of work order.
- The time frame for auditing of the software will be 30 days from the date of acceptance of work order.
