Sealed Tenders are invited from the interested dealers/dismantler/Recycler registered with Central Pollution Control Board or State Pollution Control Committee for the disposal of old/obsolete batteries in “as is where is basis”. The tender document can be downloaded from the Board's website. The tender complete in all respects and in sealed envelope superscribed as “Tender for old battery” should reach the Asst.Director (P&E), Spices Board, Cochin – 682 025 before **3 pm on 22<sup>nd</sup> June 2021.**

If the above mentioned date declared as holiday for the office, tenders will be opened in the next working day, at the time mentioned.

Bidders should fulfill the following eligibilty criteria

1. The dealer/dismantler/recycler should have registered with Central Polution Control Board or State Pollution Control Committee.
2. Bidders should have GST registration

**Inspection of the materials.**

The materials can be inspected at our office premises on all working days between 9 am to 5.30 pm from 7<sup>th</sup> June to 21<sup>st</sup> June 2021.

**Earnest Money Deposit.**

No Earnest Money Deposit or bid security is prescribed for the tender.

**Valid Period of the Bid**

Rates quoted should be valid for a period of three months from the date of opening of the tender

**Submission of Bid**

Tender should be submitted in the prescribed format as given in the last page.

**Opening of Bids.** Tenders will be opened on the prescribed date and time in the presence of members of disposal committee and the bidders or their authorised representative.

In the event of authorised representative attending the tender opening, he/she should have an authorisation letter of the bidder and his/her ID proof. Only one person or representative from each bidder is allowed to present at the time of opening of tender.

**Payment:**

The successful tenderer with highest bid will be issued with a Sale Letter and within five working days from the date of sale letter, the purchaser shall deposit full value of the material including applicable duties / taxes.

How to quote the rate

The bidder has to indicate his highest offer for the entire lot of batteries. The tender form is non transferrable. No bidder is allowed to withdraw after submission of the bids.

Spices Board reserves the right to accept or reject any bid without assigning any reason and to take any decision relating to the tender including cancellation of the tender.

If any corrigendum in respect of the above tender need to be issued, it will be available only in the Board's website.

The successful bidder shall give an undertaking that the old batteries will be stored/processed/disposed off as per Rule 12 of Chapter IV of e-waste ( Management and Handling) Rules,2011
