1. The quotation should be given to Spices Board in the format give below. The quotation with the highest value will only be considered for sale.
2. GST at the applicable rate on the bid amount will also be levied from the successful bidder.
3. The successful bidder should change the ownership of the vehicle within a period of two weeks of the sale. The successful bidder will be allowed to take the vehicle only after producing proof of having changed the ownership.

4. The security deposit will be released to all those except the first and second bidder to their bank account without any interest.

5. Security Deposit of the highest bidder will be adjusted in the sale value. Security Deposit of the second bidder will be released only after the highest bidder clears the vehicle from the premises after clearing the dues to the Board.


