Prospective bidders should visit the Board's website from time to time to take note of corrigenda if any.

The decision of the Spices Board regarding selection of the applicants shall be final and The Board reserves the right to amend or modify any of the eligibility conditions or cancel the EoI without assigning any reasons or may call fresh EoI without assigning any reason whatsoever, if it appears appropriate in the public interest. The selection of the applicants will be in accordance with the norms set out in the Guidelines. Failure to furnish complete information as mentioned in the guidelines, documents or submission of a proposal not substantially responsive to the guidelines and required documents in every respect will be at the bidders risk and may result in rejection of the proposal for shortlisting. The call for EoI is not an offer and is issued with no By submitting a proposal each bidder shall be deemed to acknowledge that it has carefully read the Guidelines and annexure thereto, if any and has fully informed itself as to all existing conditions and limitations. Responses submitted through intermediaries will not be considered and will be rejected outrightly. The objective of this Expression of Interest is to solicit proposals from the interested Dealers including the present Dealers for participation in the auction process for small and large cardamom. Applications found incomplete are liable to be rejected and no correspondence will be entertained in this regard.
