- 1. Rates of publication in newspapers and publication will be as per DAVP rates.
- 2. Agency should be able to meet and respond to urgent publication requirements.
- 3. Agency should not be involved in any litigation that may impact or compromise the delivery of services as required under this EOI of empanelment and in execution of agreement.
- 4. No advance payment will be made to the advertising agency for any of the work assigned. The payments shall be released by Board against the bills received from the agency along with the original invoice in name of agency from concerned newspaper or publications.
- 5. The Board reserves the right to remove any such agency from the empanelled list along with forfeiture of EMD, if the service provided by the Agency is found to be unsatisfactory or if the information provided for empanelment is proved to be false.
