Any corrigenda, addenda, amendments, time extension, clarification etc to the above Expression of Interest will be uploaded in our website and will not be published. Prospective bidders should visit the Board's website from time to take note of corrigenda if any.

The decision of the Spices Board regarding selection of the applicants shall be final and binding. The Board reserves the right to amend or modify any of the eligibility conditions or cancel the EoI without assigning any reasons or may call fresh EoI without assigning any reason whatsoever if it appears appropriate in the public interest. The selection of the applicants will be in accordance with the norms set out in the Guidelines. Failure to furnish complete information as mentioned in the guidelines, documents or submission of a proposal not substantially responsive to the guidelines and required documents in every respect will be at the bidders risk and may result in rejection of the proposal for shortlisting. The Call for EoI is not an offer and is issued with no commitment. By submitting a proposal each bidder shall be deemed to acknowledge that it has carefully read the Guidelines and annexure thereto, if any, and has fully informed itself as to all existing conditions and limitations. Responses submitted through agents/intermediaries will not be considered and will be rejected outrightly.

The objective of this Expression of Interest is to solicit proposals from the interested auctioneers including the present auctioneers for participation in the auction process for small cardamom.

Applications found incomplete are liable to be rejected and no correspondence will be entertained in this regard.

No fee is required to be remitted along with the submission of application for Expression of Interest.

## Details to be submitted by the Applicant against the Call for Expression of Interest

## **GUIDELINES FOR ISSUE OF AUCTIONEER LICENCE**

The following are the Guidelines on which the Auctioneer License would be issued in addition to the applicability of the provisions in the Cardamom (Licensing & Marketing) Rules 1987.

- The applicant shall be registered under Companies Act 1956 or Multi-State Cooperative Societies Act 2002 or the Indian Partnership Act 1932 or a Charitable Society registered under the Societies Registration Act 1860.
- The applicant shall produce a Bank Guarantee from a Nationalised Bank or any Banks approved the Government.
- The amount of Bank Guarantee will be computed as per the formaula given below:-

=(Total quantity of cardamom sold through auction in a cop season in kilograms / No. of auctions in the crop season) X Weighted Average Price per kilogram of cardamom for the crop season X 2.

The period from 1<sup>st</sup> August to 31<sup>st</sup> July of the last completed crop season before commencement of the block period of the preceding year will be treated as a crop season. This can be explained by means of an example based on the figures extracted for 2011-12 crop season. The total quantity of cardamom sold through e-auction (Kerala & Tamilnadu) during said period was 20306 MT in 352 auctions with a weighted average price of Rs.645.94 per kg. Therefore, the amount of Bank Guarantee applicable is worked out as: 20306/352x1000x645.94x2=Rs.745.25 lakhs.

- The revised rule will be made applicable for the Block Year 1<sup>st</sup> September 2014 to 31<sup>st</sup> August 2017 onwards.
- The application for Issue of License as Auctioneer shall be submitted along with documents and requisite fees as prescribed by the Board from time to time.

- An Affidavit on Non-Judicial Stamp Paper worth Rs 100/- has to be provided by the auctioneer-applicant at the time of submitting application for auctioneer license in the prescribed format.
- The applicant shall have a central warehouse facility to store the cardamom pooled. It is desirable that the applicant possess the facility for cleaning and grading of cardamom. Warehouse/private storage facility taken on lease/rent should be secure and it is the responsibility of the applicant to see that the facility is adequate for storage of cardamom during all seasons.
