## 1.1 Eligibility Criteria

- 1. The bidder should have experience having carried out at least two similar works undertaken during the preceding two years
- 2. The average annual turnover of the firm shall not be less than Rs.50.00 lakh during the last three financial years.

## 1.2 Scope of Works

The existing PUF Godown is having an area of 550 Sq mtr with landing space. The height of the godown is 6 mtrs. Hence the scope of the works includes
