### **TERMS & CONDITIONS**

- 1) The Director(Dev), Spices Board. will recommend for acceptance or rejection of the quotation.
2. The growers/grower groups will approach the empanelled manufacturers on thier choice for purchasing the equipment and purchase the equipment directly after making full payment. Spices Board will not be responsible for payment.
- 3) All the machinery supplied shall have a serial number or unique identification number affixed on the machinery either by way of embossing or engraving on the body of machinery or on the engine unit of the machine. Alternatively, the serial number / unique identification number should be embossed or engraved on a metal label duly revitted to the body of the machinery or the engine unit of the machine.
- 4) The list of empanelled manufacturers will be sent to all the Spices Board Field Offices as well as displayed in the Board's website.

- 5) The manufacturer should give suitable instructions/ training to the growers regarding use of machinery/ equipment at the time of delivery/ installation and arrange for servicing/ maintenance during warranty period free of cost (excluding spare parts).
  - 6) The companies shall provide a minimum of one year warranty on all the machineries from the date of delivery / installation.
  - 7) The Board is at liberty to undertake third party evaluation of the machinery supplied at any time and impose any quality check measures of the machinery even after supply to the growers.
