विषय: स्पाइसेस बोर्ड के गुणवत्ता मूल्यांकन प्रणाली के तहत मसाले एवं मसाले उत्पादों के निर्यात परेषण के अनिवार्य नमूनन एवं परीक्षण-बाबत



स्पाइसेस बोर्ड ने, संदर्भ 1 में उद्धृत परिपत्र के माध्यम से विनियमन कार्यन्वित करने वाले यूरोपीय आयोग (ई यू) 2021/2246 दिनांक 15 दिसंबर 2021 के क्रम में ई यू को अधिसूचित मसालों के निर्यात के लिए एथिलीन ऑक्साइड (ई टी ओ) के लिए बोर्ड द्वारा जारी क्लियर किए गए विश्लेषणात्मक रिपोर्ट होना अनिवार्य कर दिया था। इसके अलावा, एथिलीन ऑक्साइड (ई टी ओ) के लिए बोर्ड द्वारा जारी आधिकारिक प्रमाणपत्र, यूरोपीय संघ के गंतव्य पोर्ट के मसाले परेषण की निर्बाधता के लिए अनिवार्य आवश्यकता है।

सउदी फूड एंड ड्रग एडमिनिस्ट्रेशन (एस एफ डीए) की संशोधित आवश्यकताओं को ध्यान में रखकर, संदर्भ 3 के तहत निर्धारित, सउदी अरब को छोटी इलायची के निर्यात के लिए बोर्ड के प्रयोगशालाओं से मंजूर किए विश्लेषणात्मक रिपोर्ट की आवश्यकता अस्थायी रूप से बंद कर दी गई है। तथापि, सउदी अरब के गंतव्य पोर्टों में छोटी इलायची के परेषणों की निर्बाधता के लिए भारत के एस एफ डी ए अनुमोदित अनुपालन मूल्यांकन निकायों (सी ए बी) से अनुपालन प्रमाणपत्र (सी ओ सी) की आवश्यकता यथावत रहेगी।

तदनुसार, मसाले एवं मसाले उत्पादों की राष्ट्र/क्षेत्रवार सूची जिन्हें भारत से निर्यात के लिए बोर्ड के प्रयोगशालाओं द्वारा जारी क्लियर की हुई विश्लेषणात्मक रिपोर्ट आवश्यक है, जो उपर संदर्भ 2 के तहत परिपत्र के माध्यम से निर्धारित है, उसको सूचना एवं अनुपालन के लिए संशोधित किए गए हैं एवं अनुबंध 1 के रूप में रखा गया है।

स्पाइसेस बोर्ड अधिनियम 1986 एवं स्पाइसेस बोर्ड (निर्यातकों का पंजीकरण) विनियम 1989 के तहत जारी यह परिपत्र 01/06/2022 से प्रभावी होगा और इसके संबंध में स्पाइसेस बोर्ड द्वारा आगे की दिशा-निर्देश/अनुदेश निर्धारित किए जाने तक लागू रहेगा।

\* Container stuffing for export of Chilli Whole is permitted based on the '**Sample Drawn Certificate**' provided by Spices Board for South East Asian countries (including Malaysia), Sri Lanka, Bangladesh, Bhutan, Nepal, Pakistan, Afghanistan and China.

# Container stuffing for export of Cumin Seeds is permitted based on the '**Sample Drawn Certificate**' provided by Spices Board to all destinations except EU, USA, China and Japan. In the case of USA and Japan, exports of Cumin seeds are permitted only with the Cleared Analytical Report OR with No Objection Certificate (NOC) issued by Spices Board. In the case of EU and China, exports of Cumin seeds are permitted only with the Cleared Analytical Report from Spices Board.

\*\* The Pesticide limits specified for Curry Powders, Curry Masalas and Curry pastes for Japan are applicable only for such products which have a quantity of Chilli & Chilli products of less than 20%. For Curry Powders, Curry Masalas and Curry Pastes which have a Chilli content of 20% and above, the Pesticide limits for Chilli and Chilli products shall apply.

^^ Spices and spice products covered under HS/CN Code 0904 to 0910, ex 2103, ex 1302 ; CN Codes may also be checked, for ascertaining applicability of ETO HC.

- Health Certificate (HC) / Official Certificate for Aflatoxin from Spices Board is required for entry to the EU & UK, for consignment of Chilli and Nutmeg, and for products containing Chilli, and Nutmeg in a quantity of above 20% (either as a single product or as the sum of these products). The Health Certificate will be issued by the Board based on the Cleared Analytical Report for level of Aflatoxin.
- Health Certificate (HC) / Official Certificate for Ethylene Oxide (ETO) from Spices Board is required for entry to the EU for consignment of spices and spice products covered under HS Code 0904 to 0910, ex 2103, ex 1302. The Health Certificate will be issued by the Board based on the Cleared Analytical Report for level of Ethylene Oxide.

*Based on request from exporters, Official Certificate will also be issued for Aflatoxin and ETO for consignments to EEA countries (Iceland, Liechtenstein, Norway), Switzerland, and UK for ETO, based on the Cleared Analytical Report.*

§ In the case of RTE products, HC for aflatoxin is applicable if the item contains Chilli and / or Nutmeg in a quantity of above 20%, either as a single product or as the sum of these products. However, HC for ETO is mandatory.

'ex' Where only certain products under any ITC HS Code are to be tested and no specific subdivision under that ITC HS Code exist with description, the ITC HS Code is marked 'ex'.

The Mandatory Sampling & Testing of export consignments of Spices and Spice products does not apply to the consignments that are not intended to be placed on the market viz. trade samples, laboratory samples, display samples for exhibitions, samples that are part of passengers' personal luggage and are intended for personal consumption or use etc., unless their gross weight exceeds **30 kg**.
