Terms and conditions for renting the Built-up area:

- 1. The facilities will be rented out in "As is where is" Condition
- 2. The facilities will be rented out for one year from the date of handing over of the building space.
- 3. Spices Board will provide water and electricity to the facilities on payment on prorate basis.
- 4. The facilities will be rented out to the bidder who has quoted highest rent per month as well as meeting other terms and conditions of the Board.
- 5. The highest bidder shall execute an Agreement with the Board within 15 days of the receipt of the offer letter from the Board.

- 6. The highest bidder, after receipt of offer letter, shall pay an interest free Security Deposit equivalent to three months' rent and an interest free caution deposit of Rs.25,000/- towards guarantee against any eventual unpaid payments of electricity, rent etc. through online bank transfer to Board's Receipt Account.
- 7. The security deposit and caution deposit without interest would be returned at the time of handing over the facilities to the Board. The security deposit will have to be remitted along with the agreement.
- 8. The highest bidder shall take possession of the facility within 15 days from the date of signing of agreement and after the remittance of Security Deposit.
- 9. If the possession is not taken within 15 days from the date of agreement, it will be treated it as breach of the tender conditions and the Board has the right to lease the facilities to other eligible firm/agency.
- 10. The monthly rent with 18% GST shall be paid to Spices Board on or before $5^{\rm th}$ of every succeeding month.
