CORRIGENDUM

Sub: Revised Schedule for conducting E-auctions at Puttady and Bodinayakanur
E -auction centres from 24.10.25 to 31.10.25 (FN).
Ref. Circular No. MKTG/AUC/SCHEDULE/01/2024 Dtd. 06.10.25

Due to the sudden demise of **Mr. T. T. Jose**, Managing Director of **M/s. MAS Enterprises**, and in recognition of his valuable contributions to the **Spices Board** as well as to the **cardamom industry**, it has been decided to declare a **holiday for the e-auction centres at Puttady and Bodinayakanur on 25.10.2025 (Saturday)**, on which auctions were originally scheduled.

In view of the above, it is informed that Circular No. MKTG/AUC/SCHEDULE/01/2024 dated 06.10.2025 has been revised by shifting the auction scheduled on 25.10.2025, along with the subsequent auctions, to the next day. Accordingly, **it may be noted that 31.10.2025 (FN) will mark the end of this particular cycle**. The updated schedule to be followed by the licensed auctioneers for the block period 2023–2026 is attached herewith as Annexure–I.

The schedule is subject to change based on any revised directions issued by the Central Government, State Government, or the respective District Administration.

All auctioneers are directed to strictly adhere to the general instructions and guidelines enclosed as Annexure–II while conducting e-auctions at Puttady and Bodinayakanur.

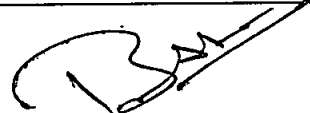

GENERAL INSTRUCTIONS :

1. The e-auctions will be conducted @ two auction per day. First auction should be commenced from 9.30 am to 1.30 pm and after the lunch break (1.30 pm to 2.15 pm), the second auction should be taken place from 2.15 pm to 6.15 pm.

2. The pooling of cardamom brought by the farmers should be given priority in the pooling centres established by the Auctioneers.

GUIDELINES:

The following guidelines are issued for strict adherence by the Stakeholders in the Pooling and Auction Centres.

1. The auctioneer shall display a notice related to washing protocol to be adopted in the pooling centre / storage areas / e-auction centres.

2. The weight of the sacks / gunny bags of cardamom shall be such that is worker can easily handle / carry it independently inside the godown without support of other worker in order to avoid contact with co-workers.

3. Adequate personal safety measures shall be taken for loading / unloading and transporting of cardamom and pooling centres / auction centres.

4. The auctioneers shall ensure that crowding is avoided in the cardamom pooling / collection centres. Appropriate measures such as token system can be adopted to avoid crowding.

5. The auctioneer shall engage minimum staff members in the pooling centre / storage area / auction centre.

6. Cleaning of the pooling / auction centre shall be undertaken on a daily basis to ensure the hygiene and sanitation.

7. Workers, farmers, traders, employees of auctioneers shall practice social distancing in the pooling centres / auction centres at any point of time.

8. The auctioneers shall display the phone numbers of health authorities / ambulance / fire etc. in the pooling / auction centre for use during emergency.
