Sub: Requirement of cleared analytical report and Official Certificate for consignment of Spices & Spice products destined to Switzerland - reg

Ref: 1. Circular No: 24/2022-23 dt. 23rd March 2023

2. Swiss Federal Council Ordinance no.817.042 of May 27, 2020

Vide reference (1) cited, Spices Board has been issuing the Official Certificate for spices & spice products exported from India to EEA countries (including Switzerland), based on the cleared Analytical Report, upon request from the exporter.

Further, it has been brought to the attention of the Board that the Port Authorities at the airports of Geneva and Zurich are demanding for an Official Certificate for the import of certain foodstuffs, in accordance with Ordinance No. 817.042 of May 27, 2020 (updated as of March 1, 2025), issued by the Swiss Federal Council. According to Annex II of this ordinance, for export of spices & spice products (that are listed in Annex II of implementing regulation (EU) 2019/1793) from India to Switzerland, an Official Certificate from Competent Authority is required for compliance with applicable standards for EtO/Pesticide Residues.

Accordingly, the consignments of spices and spice products (as detailed in **Appendix I**) exported from India to Switzerland will require an Official Certificate from Spices Board for clearance at the Border Control Points (BCP) of Switzerland. In view of the above, Spices Board will be commencing mandatory sampling and testing of consignments of spices & spice products specified in Appendix I, intended for export to Switzerland.

This circular, issued under the provisions of the Spices Board Act 1986 & Spices Board (Registration of Exporters) Regulations 1989, will take effect from 9th June 2025 and shall remain in force until further guidelines / instructions are prescribed by the Spices Board, in this regard.



Effect of this Circular: Official Certificate from Spices Board for Pesticide Residue (Curry Leaf) and EtO (for other spices mentioned in the Appendix I) will be mandatory for permitting entry into Switzerland, for the spices & spice products exported from India.
