The Spices Board of India under the Ministry of Commerce & Industry, Government of India, for the National Turmeric Board, invites online bids from reputed, experienced, and financially sound contractors/owners/agencies through a two-bid system—comprising a Technical Bid and a Financial Bid—in accordance with Rule 149 of GFR 2017, for providing rental vehicles on a monthly basis for official use of the Chairman, National Turmeric Board, Vinayak Nagar, Dichpally, Nizamabad Road, Pangra B, Boregaon, FCI Colony, Nizamabad-503230.

The contract will initially be for a period of one year, and the Board may hire the number of vehicles as mentioned in the tender document, subject to the operational requirements of the office.

Eligible and interested bidders who can meet the specifications outlined in the GeM Bid and agree to the stipulated terms and conditions are invited to submit their bids along with all necessary documents as per the guidelines given in this tender notice. INSTRUCTION TO BIDDERS

3. GENERAL TERMS AND CONDITIONS

- 1. The contractor/owner/agency shall provide an AC SUV/MUV vehicle (Innova Crysta or equivalent) at the National Turmeric Board Office at Vinayak Nagar, Dichpally, Nizamabad Road, Pangra B, Boregaon, FCI Colony, Nizamabad-503230, with Taxi Permit (less than 2 years old) (preferably white in colour), in excellent condition, along with fuel and a valid licensed driver.
- 2. The contractor/owner/agency must have a Registered Office or Branch Office located in Telangana. An attested copy of the registration certificate of the office(s) in Telangana must be enclosed with the tender document.
- 3. The contractor/owner/agency must have a minimum of 3 years of experience in providing vehicle hiring services including Central / State Govt Organization / PSUs. Copies of relevant contracts. Work orders to be uploaded along with bid in support of having provided services during each of the Financial year.
- 4. The contractor/owner/agency must have an average Annual turnover of at least **Rs.48 Lakhs** in the last **three** financial years. A copy of the turnover statement, along with the ITR, must be enclosed with the tender.
- 5. A self-certificate that the firm has not been blacklisted by any Central/State Government Department/Ministries/PSUs, etc, should be enclosed.
- 6. All fuel, repairs, maintenance, comprehensive insurance, toll, parking fees, taxes, and the driver's salary shall be the responsibility of the agency. In the event of an accident, all repairs shall be done by the contractor/owner/agency without any liabilities to the Spices Board (for National Turmeric Board) and

with no delay.

- 7. In case the vehicle cannot be used due to repairs or unavailability of the driver, a replacement vehicle and driver of the same model/category must be provided without delay.
- 8. A daily logbook should be maintained by the driver and countersigned by the designated officer, including details of kilometres used and hours.
- 9. The vehicle may be used for outstation duty (outside Nizamabad) as per the requirement. The contractor shall bear all costs associated with inter-state permits, tolls, and parking.
- 10. The driver must be experienced, well-dressed in uniform, polite, and carry a mobile phone for communication. Drivers are not entitled to any TA/DA/Halt allowances/Daily Bata etc.
- 11. The quoted rate shall be for the first **2000 Kms x 300 hours per month** inclusive of taxes, with a separate rate per additional Km/hours if any.
- 12. If the monthly running kilometres and/or running hours are less than the prescribed limit, the service charges will be reduced proportionately
- 13. The quoted rate should be fixed for the contract period. No mid-term hike will be considered or entertained on whatsoever may be the reason.
- 14. Spices Board of India (for National Turmeric Board) shall not be liable for any damage/accident during the rental/contract period. Comprehensive insurance for the vehicle is mandatory.
- 15. The quoted rate shall remain valid for one (01) year, and the contract may be extended for another one year with the same terms and rates, if required.
- 16. Incomplete bids or bids without the above documents shall be rejected without notice.
- 17. Spices Board of India (for National Turmeric Board) reserves the right to cancel the agreement at any time with one week's notice.
- 18. Spices Board of India (for National Turmeric Board) reserves the right to accept or reject any or all the bids without assigning any reason.
- 19. Payment Terms: i) The contractor shall submit the bills in duplicate on monthly basis (i.e., after completion of month) for arranging payment.
 - ii) Payment will be arranged after deducting applicable taxes and other deductions, if any.
- 20. Spices Board reserves the right to accept/reject the bids/cancel the tender at its sole discretion.
- 21. All disputes arising out of or in any way connected with the agreement/contract shall be deemed to be have arisen at Telangana and only courts in Telangana shall have the jurisdiction to determine the same.
- 22. This tender document will have to be submitted with technical bid with signature of bidder at the bottom of each page of this document. This shall mean that the bidder has agreed to abide by and fulfill all terms and conditions mentioned in it and these will be binding on the selected Service Provider along with the terms &conditions mentioned in the agreement to be executed.
- 23. Authentication of Bids: The bid shall be in typed form and signed by the Bidder or a person duly authorized to bind the Bidder to the contract. The authorization shall be in the form of a written power of attorney accompanying the proposal or in any other form demonstrating that the representative has been duly authorized to sign. All pages of the bid shall be initialed and stamped by the person or persons signing the bid.

BIDDING PROCESS

4. HOW TO SUBMIT THE BID

- 4.1.1. Opening of bids: Technical bid will be opened first and the bidders shall be either accepted or rejected. Thereafter financial bids of only those bidders shall be opened who have qualified in technical bid. The entire process of procurement or outsourcing of service under this Tender Notice shall be made online through GeM as is mandatory" under General Financial Rules, 2017. All Bidders are required to submit their bids online at https://gem.gov.in/ latest by the date and time mentioned in "Critical dates" below. No facility will be available to drop bids in tender box or to receive bids sent by hand or post or courier. Even if sent or received by any official of this office, the same shall not be considered

4.1.3. FINANCIAL BID

The Financial Bid shall be submitted exclusively through the GeM Portal.

Any inclusion of financial information within the Technical Bid will render the bid liable for immediate rejection.

4.1.4. Rate Quotation: Contractors/Agencies must quote the rate on a **per-vehicle**, **per-month basis** (2000 km x 300hour) for providing one vehicle on hire. The bidders must submit their quotation in **Indian Rupees only**. The rate must be quoted **both in words and figures**.

These charges shall be excluded from the computation of the Total Amount, which shall comprise only of the monthly charges, additional kilometre charges, and additional hour charges. Outstation night charges, wherever applicable, shall be reimbursed strictly on an actual basis.

Toll charges, parking fee or entry taxes shall be reimbursed on actual basis upon submission of proof of payment.
