Quality Requirements

The supplied materials shall:

- Be fresh and free from insects, mould, fungus and foreign matter.
- Meet FSSAI and applicable AGMARK/Spices Board quality standards.
- Be free from adulteration.
- Be subject to inspection and laboratory quality analysis before acceptance.

Evaluation

The tender will normally be awarded to the lowest responsive bidder whose bid complies with all the terms and conditions of the tender and whose samples conform to the prescribed quality specifications. However, FSTL reserves the right to negotiate with the bidder(s), split the purchase order among one or more bidders, or accept or reject any or all tenders, in whole or in part, without assigning any reason whatsoever.

General Conditions
