**NOTICE INVITING TENDER FOR DESIGNING AND FABRICATING THE STALL OF
SPICES BOARD IN SIAL INDIA 2026 AT JIO WORLD CENTRE MUMBAI**

Spices Board (Ministry of Commerce and Industry, Govt of India) is participating in SIAL India 2026 exhibition which is expected to be scheduled in the month of June 2026 at Jio World Centre, Mumbai. Board has secured 176 Sq M of bare space in two locations (Stand N 10, 116 Sq M four side open & Stand N 20, 60 Sq M three side open) for putting up two stalls facilitating the co participant traders for exhibiting spices & it's value added products in the event. In this regard Spices Board invites quotes for designing & construction of stall in the said fair with the specified requirements. The tender notice can be downloaded from the Board's website (www.indianspices.com) and central public procurement portal (<https://eprocure.gov.in/eprocure/app>).

All documents mentioned in the bid submission including the Annexures should be duly signed and uploaded on the central public procurement portal (<https://eprocure.gov.in/eprocure/app>). The last date for submitting the design & financial quote through the CPP portal is on or before 30-05-2026, 12.00 PM. The bids will be opened on 01-06-2026.

The quote will be evaluated by the committee constituted by the competent authority on the basis of:

1. **Quality** of the design (Aesthetics, facilities provided, optimum utilization of space, theme for the stall and graphics)- 50 %
2. **Cost** (Inclusive of taxes applicable)-50%

Scope of Work

The scope of work involves erection / fabrication of stalls, management of exhibition event, dismantling the fabricated structure after the conclusion of the event strictly as per the specification and time schedules given by the organizer.

| 2 | <p>Number of stalls required : 2 Spices Board has secured stand N10 and stand N 20 having the size of 116 Sq M & 60 Sq M respectively. Collectively the total area is 176 Sq M. Accordingly two separate stalls has to fabricated in the above stands. Each stall shall be of wooden platform with LED skirting, vinyl finished flooring. It should be single storied, self standing & shall not affect the structures of other stalls. The customized structure should not be compromised in quality & Strength. Minimum height of the stall should be 4 meters. Height of the periphery walls may be restricted as per the organizer guidelines. Stall must be provided with sufficient lighting according to the design and include required electrical fittings. Fascia Names shall be with background light. Provide small ramp for wheelchair access if required according to the design. Access must be given to any Fire Exit, Electrical box, Service room, etc. falling within the exhibitor's stand area. Design must have Stall Number Signage Board. The stall must be designed with reception frontage, area for Spices Board (only in stand N10), common store room (in stand N10 & N20) and remaining portion (in stand N10 & N20) shall be equally divided for 16 co participant booths, each booth having minimum 9 Sq M size.</p> |

| 5 | <p>Stall fabricator should ensure sufficient number of staff in the event venue from the beginning to the end of the exhibition for managing the stall and extending any sort of assistance as requested by the Spice Board's designated staff for the particular event.</p> |
| 6 | <p>After receiving the work order, stall designer must immediately contact the exhibition organizer for initiating the fabrication works. The stall designer should be fully aware of all construction and decoration regulations at Jio world centre, Mumbai.</p> |
| 7 | <p>It is the sole responsibility of the selected stall designer to obtain approval for design from the organizer before the commencement of erection. The stall fabrication should be in compliance with the organizer guidelines for stand construction. It will be the responsibility of the stall fabricator to remit any security deposit demanded by the organizer in connection with the event.</p> |
| 8 | <p>The stall designer shall use prefabricated structures to prevent delays in stall completion and to avoid causing inconvenience to other exhibitors. All electrical installations and wiring must be carried out by a licensed electrician. Utmost care should be taken to refrain from causing any deformation or damage to the exhibition hall during the set-up of the stall. The successful bidder after getting the work order should submit the list of electrical equipment used in the stall and the anticipated electricity load requirement.</p> |
| 9 | <p>Any ancillary services such as electricity, mandatory insurance, other payment instructions from Spices Board etc., shall be paid by the fabricator on behalf of the Board as per the directions/instructions from the competent authority or authorized staff of the Spices Board. ESSENTIAL ELIGIBILITY CRITERIA

The applicant must be empaneled/ enlisted through CPP Portal for designing & fabricating the stall of Spices Board in the International & Domestic trade fairs for the period of two years starting from 2025-26.

GENERAL TERMS AND CONDITIONS

1. The terms and conditions of the EOI for empanelment of stall fabricators will be applicable here as well and the agencies are liable to adhere to the same.
2. The agency should not be involved in any litigation that may impact or compromise the delivery of services as required.
3. The Agency shall not be allowed to transfer, assign, pledge or sub-contract its rights and liabilities under this contract to any other Company/Firm/Agency/Contractor without the prior written consent of the Board.
4. Spices Board reserves the right to reject any application without assigning any reason thereof.
5. Spice Board will have the right to increase or decrease the number of co participant booths during the time of Award of Contract & the fabrication should be according to

the final decision of Board

6. Spices Board does not make advance payments. Any request of Advance payment will be rejected summarily.
7. All communications from Spices Board regarding this tender will be from the above given email id and contact number. For any query please contact in the above email and telephone only.

SUBMISSION OF BID

The interested agency should submit the bid with following details:

- 1)** Up load PDF document containing the following details to facilitate technical evaluation (Strength, Quality, Aesthetics, optimum space utilization, innovation & creativity) of the design
 - a) Detailed design of the stall with dimensions. The front, back, top and side views of the stall.
 - b) A top view layout having grid lines with proper demarcation of components of the stall (viz, co participant booths, Spices board area, common discussion area, reception, store rooms etc.).
 - c) An enlarged perspective view of a standard co participation booth with label and pointers indicating the placement of all facilities provided within the co participation booth (viz, Glass top counter table with a branding provision, 2 chairs, Brochure stand, display shelves & spotlight, Dustbin etc.). The view should also clearly show the location of the co-exhibitor fascia and the position and dimension of branding areas in the booth.
 - d) The detailed perspective view of Spices Board area with label and lead lines showing the position of VIP seating arrangement, common discussion area, Coffee table, LED TV, Water dispenser, Reception counter, Glass Showcase, Brochure stand etc.
 - e) In addition to the above, if space permits, the bidder can upload supporting documents highlighting the aesthetics & technical sides of the design. No financial part shall be mentioned in the design or anywhere in the technical bid.
- 2)** Financial quote may be submitted in the particular field of CPP portal. The BOQ excel sheet in the prescribed format shall be filled and uploaded (only in the financial bid) to facilitate the verification of financial quote by the committee.

A bidder can submit only one proposal. If the Bidder submits more than one proposal, such proposals shall be disqualified. Bids received after the closing date and time will be rejected without any further communication on the matter.

All documents mentioned in the bid submission should be duly signed and uploaded on the central public procurement portal (<https://eprocure.gov.in/eprocure/app>) within the stipulated time.

SELECTION PROCEDURE

- The selection criteria will be QCBS with a weight age of 50% for the technical proposal (Quality) and 50 % for financial proposal (Cost). The Quotes will be evaluated by selection committee of the Board as given below:
 - **Quality of the design:** (quality & strength of the conceptualized design, aesthetics, optimum space utilization, innovation & creativity)- 50 %
 - **Cost** (Inclusive of taxes applicable)-50%
- The minimum qualifying mark for technical bid shall be 70 out of maximum 100. The bidders who score **70 mark and above** in ‘Quality’ criteria would be considered as ‘Qualified Bidder’. Bids not meeting the minimum qualifying mark in quality criteria shall be rejected. Financial proposals are then opened for only eligible and technically responsive bidders and other financial offers would remain unopened.
- The scoring pattern shall be

- The financial bid of the technically responsive bidders (Qualified bidder) will be opened subsequently and evaluated by the committee. Financial bid shall be evaluated taking into account the total price quoted including applicable GST.
- An evaluated bid score will be calculated for each bid which meets the minimum qualifying mark of 70 in ‘Quality’ evaluation criteria, using the following formula in order to have a comprehensive assessment of the bid price (Financial bid) and the Quality (Technical bid) of each bid.

$$\text{Evaluated Bid Score} = (C_{\text{low}}/C) \times 100 \times X + (T/T_{\text{high}}) \times 100 \times Y$$

where,

C = Evaluated Bid price of the Bidder

C_{low} = The lowest of the evaluated bid prices among the responsive bids

T = The total marks obtained by the bidder against quality criteria

T_{high} = The highest mark scored against Quality criteria among all responsive bids

X = 0.5 (The weightage for Quoted price is 50%)

Y = 0.5 (The weightage for quality is 50%)

- The highest scoring bidder (from the calculation as per the above formula) will be considered for awarding the tender. Spices Board reserves the right to amend, modify, add or delete, accept or reject in part or full, one or all conditions mentioned above without assigning any reason thereof.
