The Quality Evaluation Laboratory at Kochi of the Spices Board has released GeM bid, No.GEM/2024/B/5236018 dt 01.09.2024, inviting competitive offers in two-bid form from probable suppliers registered as Sellers in GeM, who are meeting procedural criteria on turn over, past performance, etc., specified in the referred GeM Bid, for supply of Immuno Affinity Column to the Quality Evaluation Laboratories situated at 8 locations in the country, for aflatoxin analysis in spices/spice products.

The total quantity to be supplied is 76,750 Nos., and to be distributed among the eight Quality Evaluation Laboratories of the Board, situated across the country. Quantity to be supplied among these QELs has been specifically indicated in the GeM bid inviting offers.

Delivery: Staggered basis to each Quality Evaluation Laboratory, in two instalments of 50% of the ordered quantity in each instalment.

Bid end date & time is 22.08.2024, 3 pm. Bid opening date & time is 22.08.2024, 3.30 pm.

Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

8. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 80% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.
