Spices Board, Ministry of Commerce & Industry, Government of India has established a Spice Park in Datauli village, Raebareli of Raebareli District of Uttar Pradesh. Spices Board invites bids for operating the warehouse having an area of 520 Sq.M available in the Park as per the following terms and conditions.

Eligibility

The following are eligible to submit the bids.

- a) Spices exporters having valid CRES (Certificate of Registration as Exporter of Spices)
- b) Spices Traders having valid GST registration
- c) Farmers Producer Companies having valid registration certificate issued by Ministry of Corporate Affairs.
- d) Commodity Exchanges
- e) Central / State Warehousing Corporation

The applicants meeting any of the above criteria will be eligible for leasing the godown.

Terms and conditions for renting the warehouse building:

- 1. The facilities will be rented out in "As is where is" Condition.
- 2. The warehouse will be rented out for three years from the date of handing over.
- 3. The rent will be increased @ 10% per annum.
- 4. The warehouse shall be used mainly for storing mint / mint products and spices / spices products.
- 5. The warehouse shall not be used for the purpose of storing of cereals and non-agriculture commodities.
- 6. The warehouse will be leased to the applicant who has quoted highest amount per month as well as meeting other terms and conditions of the Board.
- 7. In case the highest rate quoted is the same by more than one applicants, preference will be given to those who store mint / mint products in the

warehouse.

- 8. Spices Board will provide water and electricity to the facilities on payment on prorate basis.
- 9. The Interested persons/firms may visit the warehouse building on Monday to Friday from 9 am to 5.30 pm. They may contact the the Officer In Charge, Spices Park in the following address before the visit.

- 10. The highest bidder shall pay an interest free Security Deposit equivalent to three months' rent through online bank transfer to Board's Receipt Account. The security deposit without interest would be returned at the time of handing over the facilities to the Board.
- 11. The highest bidder shall pay an amount of Rs.3,00,000/- as caution deposit through online bank transfer to Board's Receipt Account. The caution deposit without interest would be returned at the time of handing over the facilities to the Board.
- 12. The security deposit and caution deposit will have to be remitted along with the agreement.
- 13. The highest bidder shall execute an Agreement with the Board within 15 days of the receipt of the Letter of Award from the Board.
- 14. The highest bidder shall take possession of the warehouse 15 days from the date of agreement and after the receipt of Security Deposit and caution deposit. If the possession is not taken within 15 days from the date of agreement, it will be treated as breach of the tender conditions and the Board has the right to lease the facilities to other eligible firm/agency.
- 15. The agreement shall be terminated by both the parties by giving 3 month's advance notice during the currency of the lease agreement.
- 16. The warehouse shall not be sub-let to any other firms.
- 17. The Board shall terminate the lease agreement if the warehousing facilities are not utilized continuously for more than 3 months or nonpayment of the monthly rent in time.
- 18. The monthly rent with 18% GST shall be paid to Spices Board on or before 5th of every succeeding month.
- 19. The facilities shall not be sub-let to any other firms.
- 20. EMD is not applicable to submit the Bid. However, the bidders shall submit

the Bid Security Declaration in the prescribed for as given in Annex-II.

- 21. The technical bid shall be submitted in the format given as Annexure-I along with Bid Security Declaration in the format given as Annexure-II in a separate envelope superscribing Technical Bid. (Envelope-1)
- 22. The financial bid shall be submitted in the format given as Annexure-III in a separate envelope superscribing Financial Bid. (Envelope 2).
- 23.
