CIRCULAR

Sub: Extension the validity of Cardamom Auctioneer Licences and Cardamom Dealer license issued during Block period 2023-26 -reg..

The **National Single Window System (NSWS)**, the online portal for submission of applications for Cardamom Auction Licences and Cardamom Dealer Licences for the block period **2026-29**, is presently undergoing technical modifications. The deployment of the renewal application functionality in the NSWS portal is anticipated to require some additional time.

In view of the above, and in accordance with the provisions of the **Cardamom (Licensing & Marketing) Rules, 1987**, the validity of the existing licences issued for the block period **2023-26** is hereby extended as follows:

A. Cardamom Auctioneer Licences

The validity of all **Cardamom Auctioneer Licences (E-Auctioneers/Manual Auctioneers)** issued for the block period **2023-26** is hereby **extended up to 31.10.2026**.

All existing **E-Auction Licence holders** shall **extend the validity of their existing Bank Guarantee up to 31.12.2026**, and the **physical copy of the Bank's amendment extending the validity of the Bank Guarantee** shall reach the undersigned **on or before 07.09.2026**.

The extension of validity of the E-Auction Licence up to 31.10.2026 shall be subject to submission of the extended Bank Guarantee, valid up to 31.12.2026, to this office on or before 07.09.2026.

B. Cardamom Dealer Licences

The validity of all **Cardamom Dealer Licences** issued for the block period **2023-26** is hereby **extended up to 31.10.2026**.

The above extension shall remain in force subject to the provisions of the **Cardamom (Licensing & Marketing) Rules, 1987** and the terms and conditions governing the respective licences.
