Validity of rank list :- Rank list shall be maintained for the trainees and shall be operated only in the event of occurrence of requirement caused by non joining of a candidate from the rank list within the date of joining as stipulated in the offer of selection issued to the candidate OR, where a candidate joins as trainee and in the event of separation of a person on account of death or resignation from the training during the period of one year from the date of joining. The validity period of the rank list shall be up to one year from the date of publication of results, unless a fresh notification for the same training is issued. Requirement which arose as stated above shall not be treated as a fresh requirement and the actual number of requirements filled up against this notification shall under no circumstances exceed the number of requirements indicated in this notification

3. The other instructions notified earlier shall remain unchanged.
