- 二、規範化粧品應標示特定香精或香料成分名之要件。（草案第二點）

二、化粧品添加附表所列之特定香精或香料成分超過下列使用濃度時，應標示其成分名，不得以標示香精、香料、Flavor、Fragrance、Parfum、Perfume 或 Aroma 表示之： (一)使用後沖洗產品：使用濃度超過百分之零點零一。 (二)非屬前款「使用後沖洗產品」者：使用濃度超過百分之零點零零一。	定明化粧品應標示特定香精或香料成分名之要件。

The labeling requirements for specific essence and spice ingredients to be disclosed.

This Draft has been translated into English according to the original Chinese version. If there is any inconsistency or ambiguity between these two versions, the Chinese version shall prevail.

- 1 The Rule is established pursuant to Item 10, Paragraph 1 of Article 7 of Cosmetic Hygiene and Safety Act.
- 2 When the concentration of any essence or spices ingredient listed in the annex exceeds the following levels, the specific ingredient must be disclosed on the label. It may not be labeled as simply "Flavor," "Fragrance," "Parfum," "Perfume," or "Aroma":
 - (1) For rinse-off products: concentration exceeding 0.01%.
 - (2) Products not classified as the above 'rinse-off products': usage concentration exceeding 0.001%.
