In line with the Article 11 of EU Regulation 2019/1793 of 22 October 2019 and its amendment from time to time, each consignment of spices listed in Annex II shall be accompanied by an official certificate in accordance with the model set out in Annex IV ('official certificate'). As per point article 11(2)(c) the official certificate shall bear the signature of the certifying officer and the official stamp.
