CIRCULAR

Sub: Modalities / Guidelines for implementation of " Sustainability in Spice Sector through Progressive, Innovative and Collaborative Interventions for Export Development (SPICED)" during the remaining period of Fifteenth Finance Commission Cycle up to 2025-26

The Ministry of Commerce & Industry vide letter No. 2/20/2020-Plant-D dated 22nd February 2024 has conveyed the approval of Spices Board's scheme (EFC proposal) titled 'Sustainability in Spice Sector through Progressive, Innovative and Collaborative Interventions for Export Development (SPICED)', for implementation during the remaining period of the Fifteenth Finance Commission Cycle, up to 2025-26.

Accordingly, Spices Board had prepared the guidelines/modalities for implementation of the scheme, which was submitted to the Ministry of Commerce & Industry for approval. Subsequently, the Ministry vide letter no.2/20/2020-Plant D dated 30th July 2024 has approved the general guidelines for the implementation of "Sustainability in Spice Sector through Progressive, Innovative, and Collaborative Interventions for Export Development (SPICED)" scheme.

Further, as instructed by the Ministry, the scheme rules for implementation of SPICED scheme were placed in the special Board meeting held on 25th July 2024 and the Board approved the scheme rules.

A copy of the Modalities / Guidelines, including general guidelines and scheme rules are attached as Annexure 1 for kind information. The online submission of application for availing assistance under various programs of the SPICED scheme will commence from 20th September 2024.

All the exporters, farmers, FPOs and other stakeholders of the spices sector are hereby requested to peruse the guidelines and make use of the opportunity for submission of applications for availing eligible assistance under the programs of the SPICED Scheme.

IMPLEMENTATION DURING THE REMAINING PERIOD OF FIFTEENTH FINANCE COMMISSION CYCLE UPTO 2025-26

A. OVERVIEW OF THE SCHEME

The Department of Commerce, Ministry of Commerce & Industry, Government of India has conveyed approval for Spices Board's scheme "Sustainability in Spice Sector through Progressive, Innovative and Collaborative Interventions for Export Development (SPICED)" for implementation during the remaining period of Fifteenth Finance Commission Cycle from 2023-24 to 2025-26, vide F. No. 2/20/2020-Plant-D, dated 22.02.2024.

The duration of the scheme will be from 2023-24 to 2025-26. Spices Board is the competent body for research, development and promotion of cardamom (small and large) as well as export promotion and quality evaluation for export of 52 scheduled spices.

The scheme is designed to expand area and improve productivity of Cardamom (small & large), generate an exportable surplus of quality spices through post-harvest improvement, export promotion of spices, increasing the share of value-added spices in the export basket, evaluating compliance of export consignments with applicable standards of quality and safety, capacity building & skill development of stakeholders etc. The scheme has the following major components covering the broad areas of Spices Board's operation, aimed at overall development of the Indian Spice Sector.

The major scheme components are :

The modalities for providing assistance under various components have been prepared, by describing the eligibility norms, unit costs and extent of support for various categories of stakeholders. The subsidy / financial incentives under the components will be disbursed by various departments of the Board depending on the types of activities / beneficiaries. This document is designed to lay down the general guidelines for implementation of the various components and sub components of the Sustainability in Spice Sector through Progressive,

Innovative and Collaborative Interventions for Export Development (SPICED) Scheme for the period from 2023-24 to 2025-26. While the overall implementation and monitoring of the scheme will be done by Secretary, Spices Board, through the Regional/ Divisional/Field offices located throughout India, the following Nodal Officers will look after implementation of the components and sub components:

Any clarification regarding components and sub-components of the scheme shall be raised by the Nodal Officer to the Secretary, Spices Board. Any changes in the guidelines for functional convenience and ease of doing business and having no financial implication shall be done by the Secretary, Spices Board. However, changes involving financial implication shall be done by the Secretary with the approval of Department of Commerce.

Scheme Coordination and Monitoring Committee (SC&MC) under the Chairmanship of Secretary, Spices Board, with nodal officers from scheme implementing Department as members will review the progress of implementation of the scheme. The SC&MC shall meet on monthly basis to oversee the implementation of the scheme and to review the physical and financial progress. Secretary shall monitor the implementation of the scheme and related aspects and furnish reports to the Department of Commerce, as and when required.

B. GENERAL GUIDELINES

1. All the services for implementation of the various sub-components of the scheme will be provided through online mode at "ServicePlus" <https://serviceonline.gov.in/> (or) Grant Management System (GMS) Portal (or any other Portal that may replace the Service Plus/GMS portal. All references to Service Plus/GMS portal in this document shall mean reference to such portal also) and all payments will be made electronically as per the procedure prescribed by Government of India. No payment will be made in cash. All the formats for applications are available online at ServicePlus/GMS portal. Small grower applicants, or any other such category of micro/small size applicants as may be determined by Spices Board, who are not able to submit online applications, may be allowed to submit physical applications to Spices Board offices. Copy of the physical applications indicating the date of receipt shall be retained/uploaded by the Board officials along with the

applications. These applications shall be uploaded online forthwith on the portal by concerned Spices Board official within 7 days of receipt of such applications while retaining the date of receipt of physical application as the date of submission. All payments in such cases shall also be through DBT or electronically as per procedure prescribed by Government of India.

2. All rules and regulations laid out and revised by Government of India under General Financial Rules 2017, CVC Guidelines and other relevant guidelines issued by the concerned Ministries/Departments of Government of India will be followed for the implementation of the Scheme..
3. All the necessary statutory compliance /laws /bylaws, as applicable, under the respective State Government or Central Government has to be obtained by the applicant before submission of application / expression of interest and the Board will not be liable for such compliances. Conditional application / expression of interest will not be accepted and summarily rejected.
4. Spices Board may, if found necessary, consult Central Government, State Governments of cardamom / spices producing states and other concerned agencies depending on the activity/component under consideration and implementation of the activity.
5. 30 days prior to the commencement of submission of applications online, the schemes will be announced on the website of Spices Board (www.indianspices.com) and given wide publicity through various channels of communication (including print, social media etc.) along with the details of documents to be uploaded with the application. If any deviation for the 30-day lead time is essential, the concerned department/division of Spices Board shall get the relaxation from the Secretary by mentioning the specific reason. However, sufficient lead time so as to ensure wide publicity of the scheme should still be maintained.
6. The financial and physical targets of the Scheme will be adhered subject to availability of funds provided to the Board by Government of India through budget allocation.
7. The details of allocation under a component and its sub-components shall be made available on the public website of Spices Board, before applications are invited against the various sub-components. The details of all beneficiary applications received shall also be made available on the public domain of Spices Board as soon as possible after the specified last date of receiving applications, and the status of acceptance/rejection shall also be updated in the website.
8. For components which involve financial assistance to beneficiaries, the details such as eligibility criteria, scale of assistance, list of documents required, process of submission and scrutiny of applications, conditions to be fulfilled for sanctions and disbursement of funds and other conditions along with necessary forms and declarations shall be provided in the detailed scheme rules/modalities to be issued by Spices Board. The rates of assistance, cost norms, eligibility and all other conditions mentioned in the EFC memorandum (read along with EFC recommendations and approvals granted by Central Government) shall be strictly adhered to while issuing of detailed Scheme rules/modalities by Spices Board and no deviation from the same shall be allowed unless specifically approved by the Central Government.
9. The general modalities/guidelines along with detailed scheme rules issued by Spices Board shall be uploaded on the website of the Board.
10. The operation of the Scheme shall be periodically audited by the Internal Audit Division of the Board and necessary arrangements shall be made for audit by Comptroller and Auditor General.

11. The entire processing of application right from receipt of application / expression of interest online till disbursement of subsidy shall be completed within the scheme period (2023-24 to 2025-26) and will not be carried forward/ spilled over beyond 31.03.2026.
12. Verification of works completed shall be done in accordance with the individual component/sub-component requirements before disbursement of scheme funds. Geo tagging shall be done for all scheme activities wherever locations can be mapped.
13. If the applicant violates any of the terms and conditions contained in guidelines or any of the instructions from the Board or in case of any misappropriation of the financial assistance granted by the Board or make any wrong claim, the Board shall have the right to demand and enforce repayment forthwith of the entire amount of the assistance granted by the Board along with penal interest @ 15% p.a. Further such entities will also be ineligible for assistance under any scheme implemented by Spices Board till the time such recovery is completed.
14. Applications of persons who resort to making offers, rewards, gifts or any material benefit or any coercion either directly or indirectly, to influence the sanction process shall summarily be rejected. Legal action will be initiated for recovery with applicable interest against applicants who obtain the benefit by willfully furnishing wrong/incorrect information, misrepresentation and suppression of information.
15. Applications satisfying all the required conditions and eligibility criteria as specified in scheme rules will be processed on first come first serve basis. Priority will be given to beneficiaries, who have not availed the schemes in previous years.
16. Acceptance of the application is only a confirmation towards completion of scrutiny of the application and does not entitle the applicant for financial assistance under the scheme.
17. For judicious and timely disbursement of fund, Secretary may temporarily reallocate the fund within the same component and from one component to other, not exceeding the approved allocation for the component for the financial year.
18. Wherever possible, the scheme component shall be implemented through small grower collectives like grower clusters. All individual applicants will have to submit a copy of Aadhaar and bank account details and all transaction will be Aadhaar based. Whereas for collectives, the payment will be on DBT mode.
19. No deviation from guidelines will be allowed at any stage by the Zonal Offices or Field Offices. Clarification regarding components and subcomponents of the scheme, if any, shall be sought by the respective Nodal Officer from the Secretary, Spices Board.
20. Spices Board may invite applications in one or more batches, depending on the response and the availability of funds.
21. The Spices Board shall prepare a comprehensive plan for activities to be undertaken under the Trade Promotion component and submit for the approval of Department of Commerce.
22. Under the sub component "Product & Market Development and Branding of Indian Spices" promotion campaigns for Indian Spices may be undertaken by Spices Board jointly with the Industry stakeholders wherever possible. A committee may be formed by Spices Board including Board officials and external experts (with established credentials and reputation in advertising, marketing and promotion, not limited to Spices sector) for evaluating and finalizing such joint promotion proposals.

C. Receipt and Scrutiny of Application

1. All application should be submitted online.
2. On successful submission of application, an application ID will be assigned. The application ID is just a confirmation towards receipt of application and does not entitle the applicant towards eligibility for financial assistance under the scheme.
3. The application will be scrutinized against the eligibility criteria and conditions specified in the scheme rules and the acceptance/rejection will be updated online.
4. Any application incomplete on account of lack of documents confirming such compliances will be summarily rejected.
5. Wherever inspections/field verifications are required prior to acceptance of application, these inspections will be carried out by officials of Spices Board after receipt of application within a period specified by the Board as part of their service delivery benchmarks in citizen charter. Geo tagged photographs shall be captured by the inspecting officer online, along with the inspection report.
6. Post receipt of inspection report, fulfilment of eligibility criteria and conditions, and scrutiny of documents submitted, the status of such applications will be updated online as accepted. Acceptance of the application is only a confirmation towards completion of scrutiny of the application and does not entitle the applicant for financial assistance under the scheme.

D. Intimation of completion of Activity

1. Within a period as specified under scheme rules of each component, the applicant shall upload a completion report online along with supporting documents wherever applicable as per scheme rules.
2. On receipt of completion report and wherever applicable as per scheme rules, inspection will be carried out by officials of Spices Board. Upon submission of completion report, this next step of inspection will be proceeded with only if the budget under the sub-component has not been exhausted and government sanction against the budgeted amount has been issued.

E. Issuance of sanction/Disbursement

1. On receipt of inspection report (wherever applicable) and/or completion report, either sanction for assistance will be accorded or the application will be rejected and the status will be uploaded online. Accordance of such sanction will be subject to the availability of fund with Spices Board for the financial year.
2. The disbursement of financial assistance to the beneficiaries will be completed within a period specified by the Board as part of their service delivery benchmarks in the citizen charter subject to availability of fund with Spices Board.

F. SCHEME RULES / MODALITIES

SCHEME COMPONENTS AND SUB COMPONENTS

Component I: Improving Productivity of Cardamom (Small & Large) & Component II: Post-Harvest Quality Up gradation of Spices

- 1) The programs will focus on farmers groups such as FPO/FPC/SPS and individual growers in potential spices growing areas. Priority will be given to the applications by groups/FPO/FPC/SPS etc. or its members for post-harvest improvement programmes. Wherever sufficient applications from groups/FPO/FPC/SPS etc are not received, applications of individual growers will be considered.
- 2) Farmers Groups seeking assistance need to be a legal entity such as Reg. Society/FPC/FPO/SHG/SPS etc. and an agreement has to be executed with the Board in the prescribed format in Rs.200/- stamp paper and release of assistance will be subject to conditions laid down by NITI Aayog.
- 3) In the case of QGBG the farmers group will pay 10% of the cost of post-harvest equipment to the vendors empanelled under the Board and 90% of the cost with cost ceiling as per norm will be paid as bank account transfer by the Board to the empanelled vendor on successful installation of the equipment/device in the identified premises of the group, for ease of procuring the machines/equipment by group. If any unforeseen technical glitches are faced in having the above arrangement in place, the group will have to pay 100% amount to the empanelled vendor and the eligible assistance to the group will be reimbursed from Spices Board through PFMS. The eligible assistance will be provided to the group only on execution of an MoU with the Board. If the amount of assistance per group exceeds Rs.15 lakhs at a time, the same has to be recommended by a committee constituted with Director (Development), Regional Deputy Director and Assistant Director and recommendation report will be submitted to the competent authority of Spices Board for approval.
- 4) The assistance under a program will be available to a beneficiary only once, except in programs where it is specifically mentioned in guidelines about further assistance in the guidelines.

1. All exporters of spices who possess a valid CRES can apply for assistance under the components- Enhancing Capacities for Market Expansion, Trade Promotion and Technological Interventions, subject to fulfillment of the respective eligibility criteria.

2. Preference will be given to the applicant based on appropriate criteria such as first-time applicants, SMEs, FPC/FPO/SPS, focus sectors/region, high end value-addition segments etc., as deemed required.

3. In the case of Programs which require fulfillment of export obligation, Secretary, Spices Board may extend the period for fulfilling export obligation, if deemed appropriate.

4. The firms which have shareholding of more than 51% by SC/ST/ entrepreneurs only will qualify for assistance under the SC/ST/ category.

5. In the case of exporters who have the provision to refund the GST amount, the Board will not consider the GST component while providing the assistance.

6. Processing fee will be applicable for availing assistance under the following Programs, as given in the table below:

Export Obligation for availing assistance

The beneficiaries are required to fulfil export obligation by exporting spices and spice products worth FIVE times of the amount of assistance availed from the Spices Board over and above their average export performance during the immediate past three years, within a period of FIVE years from the date of completion of the project in the case of general category. In the case of MSME exporters, the export obligation will be THREE times of the amount of assistance availed from the Spices Board over and above their average export performance during the immediate past three years, within a period of FIVE years from the date of completion of the project.

For SC / ST exporters, FPO exporters, units in NE region (including Sikkim and Darjeeling & Kalimpong Region of West Bengal), other Himalayan states / Himalayan UTs and Islands (Union Territories of Andaman & Nicobar and Lakshadweep), the export obligation will be THREE times of the amount of assistance, to be fulfilled in FIVE years from the date of completion of the project.

For discharging the export obligation, the export effected directly by the beneficiary as well as the supplies made by the beneficiary to other exporters for export will be considered.

The details of mechanisms/instruments to secure fulfilment of Export Obligation(EO) is given below

a) Bank Guarantee (BG): The BG value shall be 110% of the assistance released. The BG amount may be revised annually based on the fulfilment of export obligation. In case of non-fulfillment of export obligation, the BG will be invoked proportionate to the unfulfilled EO with interest at 10% of the unfulfilled EO. The bank guarantee will be released on fulfilment of the required export obligation.

b) Escrow Account: The exporter may open an escrow account with the bank and the assistance from the Board may be transferred the escrow account. The export proceeds of the firm shall be monitored periodically and the assistance amount may be released to the exporter proportionately. Further, the Banks may be asked, not to charge interest on the amount available in the

Based on the recommendation by the committee, the Spices Board will issue In-principle approval letter to the applicant, indicating the details of items(with cost) considered under the program, so as to complete the project within the time specified by the Board and submit the following documents:

1. Completion report certified by Chartered Engineer or any other competent technical organization and Installation Report by the vendor/service provider.
2. Copies of bills/vouchers / receipts (self-attested), related to the expenditure.
3. Expenditure statement duly certified by the Chartered Accountant
4. Bank statement detailing payments released for the approved components of the project
5. Additional documents, if required by the Board

On receipt of the completion report and supporting documents from the applicant, the Spices Board will arrange for inspection of the unit by a team of officers to assess the eligible project

components to be considered for assistance under the program.

Based on the recommendation of the inspection team, supporting documents and subject to availability of funds, the Board will issue a sanction letter specifying the eligible amount of assistance to the exporter. The amount of assistance will be disbursed after executing an agreement with the Spices Board and after securing fulfilment of Export Obligation through mechanisms/instruments such as Bank Guarantee, Escrow Account, other suitable mechanisms / instruments etc.

Export Obligation for availing assistance

The beneficiaries are required to fulfil export obligation by exporting spices and spice products worth FIVE times of the amount of assistance availed from the Spices Board over and above their average export performance during the immediate past three years, within a period of FIVE years from the date of completion of the project in the case of general category. In the case of MSME exporters, the export obligation will be THREE times of the amount of assistance availed from the Spices Board over and above their average export performance during the immediate past three years, within a period of FIVE years from the date of completion of the project.

For SC / ST exporters, FPO exporters, units in NE region (including Sikkim and Darjeeling & Kalimpong Region of West Bengal), other Himalayan states / Himalayan UTs and Islands (Union Territories of Andaman & Nicobar and Lakshadweep), the export obligation will be THREE times of the amount of assistance, to be fulfilled in FIVE years from the date of completion of the project.

For discharging the export obligation, the export effected directly by the beneficiary as well as the supplies made by the beneficiary to other exporters for export will be considered.

The details of mechanisms/instruments to secure fulfilment of Export Obligation(EO) is given below

a) Bank Guarantee (BG): The BG value shall be 110% of the assistance released. The BG amount may be revised annually based on the fulfilment of export obligation. Organizations for processing and value addition of export oriented spices at district/ cluster level etc).

The assistance under components a, b & c will be limited to the cost of machinery / equipment /control system included in the equipment/electrical items related /connected to equipment, ancillary installations, supporting facilities/ items such as control panel, laying electrical cables, etc and installation / erection charges etc, as applicable.

The maximum amount of assistance will be reviewed periodically and a higher ceiling will be fixed for costlier equipment/ kits, without any change in the scale of assistance.

An exporter can avail the assistance for promoting the approved brand in export destinations in upto three installments. Exports of spices in all forms in branded consumer packs will qualify for availing the assistance.

An indicative list of activities for which assistance will be provided under Branding & Marketing are In-store Branding, Shelf Space Renting, Slotting / Listing Fee, Electronic/ social media and Print Media, outdoor publicity, billboard, commercial advertisement on channels, cooking demonstrations etc. It is proposed to also cover any such activity that is essential to meet the changing international market dynamics and that helps in building the brand image, etc.

Documents to be submitted:

- a) Application in the prescribed form
- b) Comprehensive proposal covering details of the market promotion to be undertaken
- c) Annual cost break up in each segment/market
- d) Copy of the valid Brand registration certificate from the Spices Board
- e) Last year balance sheet of the company certified by the chartered accountant, as applicable
- f) Copy of SC/ST Certificate (for SC/ST beneficiaries/groups)

On receipt of the application, proposal and other supporting documents, the feasibility of the project will be evaluated by the committee constituted by Secretary, Spices Board. The exporters whose applications are found feasible will be called up for presenting the proposal, before the committee. Based on the recommendation by the committee, the Spices Board will issue In-principle approval letter followed by execution of an agreement

with the Spices Board. The total approved amount for the programme will be released in three instalments in proportion to the proposed expenditure for the approved activity, based on an agreement executed with the Board and after ensuring repayment of loan amount / securing fulfilment of Export Obligation through mechanisms/instruments such as Bank Guarantee, other suitable mechanisms / instruments etc.

The first instalment will be released as advance, on execution of the agreement and completion of necessary documentation. The second and third instalments will be released , after evaluation and review by the committee of activities undertaken and expenditure incurred, subsequent to the release of the previous instalment(s) Payment shall be in Indian currency only and foreign exchange requirement, if any, has to be met by the exporter.

Export Obligation for availing assistance

The beneficiaries are required to fulfil export obligation by exporting spices and spice products to the identified overseas markets under the program, worth FIVE times of the amount of assistance availed from the Spices Board. In the case of MSME exporters the export obligation will be exports worth THREE times of the amount of assistance availed from the Spices Board to the identified overseas markets, under the program. The period for fulfilment of the Export Obligation is from the date of drawing the first instalment to FIVE years from the date of drawing the final instalment of the loan.

For SC / ST exporters, FPO exporters, units in NE region (including Sikkim and Darjeeling & Kalimpong Region of West Bengal), other Himalayan states / Himalayan UTs and Islands (Union Territories of Andaman & Nicobar and Lakshadweep), the export obligation will be EQUAL to the amount of assistance availed from the Spices Board. The period for fulfilment of the Export Obligation is from the date of drawing the first instalment to FIVE years from the date of drawing the final instalment of the loan.

For discharging the export obligation, the export effected directly by the beneficiary as well as the supplies made by the beneficiary to other exporters for export will be considered.

The details of mechanisms/instruments to ensure repayment / secure fulfilment of Export Obligation (EO) is given below

a) Bank Guarantee (BG): The BG value shall be 110% of the assistance released. The BG amount may be revised annually based on the fulfilment of export obligation. In case of non-fulfillment of export obligation, the BG will be invoked

proportionate to the unfulfilled EO with interest at 10% of the unfulfilled EO. The bank guarantee will be released on fulfilment of the required export obligation. The BG shall be renewed well before the date of expiry/ enhanced as and when required/further instalments of loan are sanctioned /released.

b) Other suitable mechanisms / instruments etc: Based on the developments in the banking and credit management system other suitable mechanisms / instruments to ensure repayment/ secure fulfilment of the Export Obligation will be considered, by the Board.

At utilization of each instalment, the exporter has to give a detailed account of the activities undertaken along with a progress report. Also, statement that the loan has been fully utilized for the sanctioned purpose should be submitted along with expenditure statement, supporting documentary evidence for the expenditure incurred/committed for the next phase, export statistics for the specified brands etc. In the absence of proper documentary evidence and satisfactory report, Board shall reduce the instalments or discontinue the assistance.

The repayment of the loan shall be in four equal annual instalments and the repayment shall start within 24 months from the release of the final instalment and shall end within 60 months from the release of the final instalment

In the event of default in repayment or non-fulfilment of export obligation, the Board reserves the right to invoke the Bank guarantee or mechanisms/instruments to ensure repayment of the outstanding loan amount with applicable interest and to secure fulfilment of applicable Export Obligation.

Also, if the exporter fails to submit the complete report along with all the documents for the first instalment availed or submit the report with documents but does not avail the subsequent instalment(s) , the BG submitted by the exporter or such mechanisms/instruments applicable under the program will be invoked proportionately, so as to secure the applicable dues along with penal interest.

100% of the expenditure for the promotional activities / marketing / PR campaigns and other promotional programmes conducted by Spices Board to promote and popularize the Indian spices, cuisine, brands, Indian spices logo etc, with a view to build and strengthen the global brand image of Indian spices will be met under the program. These campaigns aim at projecting India's capacities and capabilities in the spices sector, with a view to increase the customer recall for Indian spice brands as well as Indian cuisine, which invariably contain spices.

Research-oriented programs for the development of value-added products, including evidence-based validation of health and nutraceutical benefits of spices, process development, monitoring of bioactive compounds during the processing of spices, studies on storage of value-added products etc are considered under this programme. Quality and safety evaluation of value-added products for sustainable markets, including development of analytical methods for the quality and safety evaluation of value-added products, marker-based standardization of value-added products, and development of quality standards for spice-based value-added products and harmonization with international standards will also be considered under this programme.

In addition to the scope for deriving new end uses and applications from the spices produced within the country, there is a need to support exporters/expert institutions in development of technology-based solutions / equipment/ devices/ new products to meet the changing requirements of the spices sector, so as to enable the Indian spice industry to keep abreast with latest global developments/ requirements.

The assistance will be 50% of the cost of Product Development, Research, including development of new devices / equipment/ validation of technology subject to a maximum of Rs.1.00 crore, if clinical trials (international), patenting and commercial / regulatory approvals (EPA, FDA etc) are involved. If clinical trials, patenting etc are not involved, the assistance will be limited to Rs. 25 lakhs. The assistance towards cost of equipment, if any, will be considered upto a maximum of 25% of the project cost

In the case of Central/ State Universities, R&D and other institutions of the Govt., assistance will be up to 100% of the cost of the project subject to a maximum of Rs.1.00 crore, if clinical trials (international), patenting and commercial / regulatory approvals (EPA, FDA etc) are involved. If clinical trials, patenting etc are not involved, the assistance will be limited to Rs. 25 lakhs. The assistance towards cost of equipment, if any, will be limited to a maximum of 25% of the total assistance.

On receipt of the application, Project proposal and other supporting documents, the Board will examine the feasibility of the proposal with the aid of an external technical expert and if the proposal is found satisfactory after technical evaluation, the exporters/research institutions/universities will be called up for presenting the proposal, before the committee constituted by the Spices Board. Based on the recommendation by the committee, the Spices Board will issue In-principle approval letter to the applicant, indicating the details after which a Memorandum of Understanding (MoU) will be executed between Spices Board & the applicant, so as to proceed with the project.

The financial assistance will be released in three installments, as given below, unless the MoU executed in this regard provide otherwise;

1. The first instalment of Spices Board share as per the MoU, will be released as advance on signing the MoU to begin the research work.

2. The second instalment of Spices Board share as per the MoU will be released as advance after significant progress is made in the proposed research work and on submission of progress report and expenditure statement for the amount released as first instalment, supported by self-attested bills and vouchers, along with cost of equipment/ instruments required during the period.

3. Balance amount of Spices Board's share as per the MoU will be paid as third and final instalment after completion of the research work and on submission of final & completion report along with a detailed presentation before the committee constituted by Secretary, Spices Board.

The EOIs received will be evaluated by an Incubation Appraisal Committee consisting of members from Spices Board and CFTRI constituted by Secretary, Spices Board. The incubatees will be called up for presenting their idea/ proposal through online before the committee. Based on the recommendation of Incubation Appraisal Committee, the applicants will be short

listed and the shortlisted applicants will be informed to submit detailed viable proposal viz. details of R&D works, Details of infrastructure required viz. space, work station, PC, specialized instrumentation support, requirement of mentoring, investment, total cost of the project, funding support received or to be received, timeline, anticipated benefits /outcome for the spices sector including contribution to the exports, intellectual property declaration etc.

The short listed applicant will present their detailed viable proposal before a Committee of Experts consisting of officers from Spices Board, CFTRI, external expert if any, constituted by Secretary, Spices Board. The Committee of Experts will select the suitable applicant as Incubatee under the scheme. The Board will issue In principle approval letter to the incubatee, followed by an execution of agreement with the Board.

The selected Incubatees will be provided support for covering aspects such as technical support, mentors, access to relevant equipment, resources and knowledge sources, through the Expert Institute. The duration of support/assistance to an incubatee under the program shall be 12 months. The Board may grant an extension upto 6 months, upon receipt of such request from the incubatee, depending on the progress achieved by the incubatee and based on the recommendation of the committee of experts. In such cases, the incubatee will be allowed to use the facilities of the expert institute, subject to payment of charges prescribed by the expert institute for the facilities/services provided by them. For extension of the incubation period, additional cost, if any shall be paid by the incubatee, directly to the incubation centre.
