Annexure D

Terms and Conditions of Limited Tender

- 1. Participation in this tender is by invitation only and is limited to the selected Procuring Entity's registered suppliers. Unsolicited offers are liable to be ignored. However, suppliers who desire to participate in such tenders in future may bring it to the notice of Procuring Entity and apply for registration as per procedure.
- 2. The quotation shall be in the form furnished by Procuring Entity and should be free from corrections/erasures. In case there is any unavoidable correction, the same should be properly attested. If not, the quotation will not be considered. Quotation written in pencil will not be considered.
- 3. Quotation will be opened on due date at 3.00 pm at the indicated venue & date in the Notice Inviting Tender in presence of the tenderers or their representatives who may wish to be present.
- 4. Spices Board India reserves the right to accept the offer by individual items and reject any or all tenders without assigning any reason thereof and does not bind itself to accept lowest quotations.
- 5. The items to be offered shall have a shelf life period of minimum 6 months, duly certifying the same on the packet. If this declaration is not there on the packet, the same shall be summarily rejected.
- 6. Manufacturer's name and country of origin of materials offered must be clearly specified. Please quote whether your organisation is large scale industry or small scale industry. If you have NSIC/MSE/MSI/DGS&D Certificate, please attach self-attested copy of the same to the quotation. Mention your registration details in the tender form.
- 7. Spices Board India reserves the right to modify the quantity specified in this enquiry.
- 8. Rates quoted shall be for free delivery at destination (F O R DESTINATION AT THE RESPECTIVE QUALITY EVALUATION LABORATORY) inclusive of all the overheads such as P&F, GST @ the applicable rate, etc., otherwise the quotation is likely to be rejected. However, the rate of P&F shall invariably be mentioned in the quote which shall be indicated in the invoice to be furnished along with the supply after placement of order.
- 9. The prices quoted shall be firm till the supplies are completed.
- 10. Delivery shall be on staggered basis as indicated in the delivery schedule (Annexure-B).
- 11. Spices Board India reserves the right to recover any loss sustained due to delayed delivery by way of penalty. Failure to supply the material within the stipulated period shall entitle Procuring Entity for the imposition of penalty without assigning any reasons @ 1/2% (half percent) of the total value of the item covered in order as penalty per day subject to a maximum of 5% (five percent) unless extension is obtained in writing from the office on valid ground before expiry of delivery period.
- 12. Payment terms : 100% within 30 (thirty) days on receipt and acceptance of material at our site in good condition.
- 13. DEFAULT

In the event of any default by Seller to comply with any of the provisions or requirements of the Order, Spices Board India shall have the right to terminate and cancel the Order with or without notice and without prejudice to any other rights, options, or remedies Spices Board may have. In the event of such cancellation of the Order, Spices Board India shall be entitled to arrange for the procurement of items from alternative suppliers at the risk and cost of the Seller. The waiver of one default shall not be considered on automatic waiver of any other default.

14. Dispute clause: Any dispute relating to the enquiry shall be subject to the jurisdiction of the court at Ernakulam only.

15. SUSPENSION AND TERMINATION

Spices Board India reserves the right to suspend the Order in whole or in part by written notice to Seller at any time prior to despatch of item by Seller. On receipt of notice of suspension from Spices Board India, the Seller shall immediately stop all activities related to Order. On receipt of notice removing the suspension, the Seller shall re-commence the execution of the Order and complete it as per the terms of the Order, provided that the delivery period specified in Order shall be extended corresponding to the period of suspension. If period of suspension exceeds six (6) months, Order shall be deemed terminated.

16. FORCE MAJEURE

17.1. Neither party hereto shall be held responsible for any delay of failure to perform any or all the obligations under Order caused by Force Majeure. In such a case the time for performance or such obligations and the obligations of the other party to the extent that they are affected by such occurrence will be extended by such period as is duly justified. Notification of a circumstance of Force Majeure shall be addressed to the other party within two (2) working days of its occurrence. This communication shall be confirmed by a letter despatched within one (1) week, along with appropriate documentary evidence confirming the existence of a situation of Force Majeure.

17.2. For the purposes of this clause, Force Majeure means

- i. War or hostilities
- ii. Riot or civil commotion
- iii. Earthquake, flood, tempest, lightning or other natural calamities, epidemics
- iv. Accident, fire or explosion not caused by wilful negligence of Seller
- v. Labour strikes or lock-out exceeding ten (10) days in duration not caused by any deliberate act or indiscretion by Seller.
- vi. Law and Order Proclamation.

17.3 However, should such a delay, even if due to reason of Force Majeure be protracted for more than three (3) months, Spices Board India shall have the right to cancel order at no charge to Spices Board India and Spices Board India shall be entitled to the reimbursement of any amount already paid to the Seller.

18. SUB-LETTING or assignment of whole or part of the order shall not be permitted except with the prior approval of Spices Board India obtained in writing.

19. Spices Board India reserves the right to cancel this Notice Inviting Tender at any time before issue of the Purchase Order, without assigning any reason. Bidders are not entitled to claim any damage or compensation in case of such cancellation.

20. The tender is issued subject to the jurisdiction of the local courts at Ernakulam only. All disputes arising out of the tender notice and resultant sale order shall have the jurisdiction of the competent Court at Ernakulam.
