**Method of Selection:** Selection will be through multiple choice (MCQ) written test of PG level standard for One hour duration.

**How to apply :**

Eligible candidates may appear for a walk -in- test along with their applications in prescribed format( Annexure-I ), originals of identity proof (Government approved,) Proof for age, education and experience and one set of self attested copies of above mentioned certificates **on the date and time at the address given above.**

3. Before applying, candidates should ensure that they fulfil the eligibility criteria for the post.
