The candidates reporting after the specified time or fail to submit their application online will not be permitted to participate in the test. 2. Candidates are required to report at the venue at least 30 minutes prior to the scheduled time for certificate verification. They must bring all original documents and certificates, along with one set self attested copies each, pertaining to identity, age, educational qualifications for verification purpose 3. The number of trainees indicated is provisional and may vary at the time of selection. 4. The selection as Trainee(QEL Chemistry) in Spices Board is only a training and under no circumstances are linked to regular appointments and cannot be regularized at any stage. 5. Before applying, candidates should ensure that they fulfill the eligibility criteria for the training as mentioned above. 6. In case it is detected at any stage of recruitment that a candidate does not fulfill the eligibility norms and / or that he/she has furnished any incorrect / false information or has suppressed any material fact(s), his/her candidature will stand cancelled. If any of these shortcomings is/are detected even after selection, his/her services are liable to be terminated. 7. Decisions of the Spices Board in all matters regarding eligibility, conduct of test, detailed test and selection procedure would be final and binding on all candidates.
