The last date for submitting online application is 08/09/2026. 2. Candidates are required to report at the venue at least 30 minutes prior to the scheduled time for certificate verification. They must bring all original documents and certificates, along with one set self attested copies each, pertaining to identity, age, educational qualifications for verification purpose. 3. The number of trainees indicated is provisional and may vary at the time of selection. 4. The selection as Trainee (Marketing) in Spices Board is only a training and under no circumstances are linked to regular appointments and cannot be regularized at any stage. 5. Before applying, candidates should ensure that they fulfill the eligibility criteria for the training as mentioned above. 6. In case it is detected at any stage of recruitment that a candidate does not fulfill the eligibility norms and / or that he/she has furnished any incorrect / false information or has suppressed any material fact(s), his / her candidature will stand cancelled.
