They must bring all original documents and certificates, along with one set self attested copies

The selection as Sample Receipt Trainee in Spices Board is only a training and under no circumstances are linked to regular appointments and cannot be regularized at any stage. 5. Before applying, candidates should ensure that they fulfill the eligibility criteria for the training as mentioned above. 6. In case it is detected at any stage of recruitment that a candidate does not fulfill the eligibility norms and / or that he/she has furnished any incorrect / false information or has suppressed any material fact(s), his / her candidature will stand cancelled.
