**Method of Selection:** Shortlisted applicants will be called for written test by the Board. A rank list of the applicants who qualify in the test will be formed and will be engaged as Official Language Trainee as per the requirement of the Board.

2. Candidate has to submit the application online. Applications received in any other mode will not be considered.
3. List of shortlisted applicants for test/interview will be published in Board's website. Date & time of written test and/or interview will be informed in due course.
4. The eligibility of applicants with respect to age, qualification etc. will be determined as on the last date for receiving application.
5. The period of experience shall be counted after obtaining the prescribed educational qualification.

If any of these shortcomings is/are detected even after selection, his/her training is liable to be terminated.
