**NOTICE INVITING TENDER FOR DESIGNING AND FABRICATING THE STALL OF  
SPICES BOARD IN THE WORLD FOOD INDIA 2025,  
AT PRAGATHI MAIDAN, NEW DELHI**

Spices Board (Ministry of Commerce and Industry, Govt of India) is participating in World Food India 2025 exhibition which is scheduled from 25-28 September 2025 at Pragathi Maidan, New Delhi. Board has secured 200 Sq M of bare space for putting up a stall facilitating the co participant traders for exhibiting spices & it's value added products in the event. In this regard Spices Board invites quotes for designing & construction of stall in the said fair with the specified requirements. The tender notice can be downloaded from the Board's website ([www.indianspices.com](http://www.indianspices.com)) and central public procurement portal (<https://eprocure.gov.in/eprocure/app>).

The design should be duly signed and uploaded on the central public procurement portal (<https://eprocure.gov.in/eprocure/app>) as mentioned under the sub heading '*bid submission*' in this notice. The last date for submitting the design & financial quote through the CPP portal is on or before **13-09-2025, 3.30 PM**. The bids will be opened on **15-09-2025**.

The quote will be evaluated by the committee constituted by the competent authority on the basis of:

1. **Quality** of the design (Aesthetics, facilities provided, optimum utilization of space, theme for the stall and graphics)- 50 %
2. **Cost** (Inclusive of taxes applicable)-50%

## Scope of Work

The scope of work involves erection / fabrication of stalls, management of exhibition event, submitting mandatory forms as required by the organizer, getting design approval from the organizer on time, payment of electricity charges, dismantling the fabricated structure after the conclusion of the event strictly as per the guidelines and time schedules given by the organizer.

2	Number of stall required : 1 The stall shall be of wooden platform with LED skirting, vinyl finished flooring. It should be single storied, self standing & shall not affect the structures of other stalls. The customized structure should not be compromised in quality & Strength. Minimum height of the stall should be 4 meters. Height of the periphery walls may be restricted as per the organizer guidelines. Stall must be provided with sufficient lighting according to the design and include required electrical fittings. Fascia Names shall be with background light. Provide small ramp for wheel chair access if required according to the design. Access must be given to any Fire Exit, Electrical box, Service room, etc. falling within the exhibitor's stand area. Design must have Stall Number Signage Board. The stall must be designed with reception frontage, area for Spices Board & remaining portion shall be equally divided for 25 co participants.
3	<b>Co participant area</b> Number of co participant booths required : 25 25 individual booths shall be there in the stall for accommodating 25 co participants with following facilities. How ever it may also be noted that Spice Board will have the right to increase or decrease the number of co participant booths during the time of Award of Contract & the fabrication should be according to the final decision of Board. <ul style="list-style-type: none"><li>• Glass top counter table with a branding provision.</li><li>• 2 chairs for each exporter. Brochure stand.</li><li>• Fascia Names (With background light).</li><li>• Full size branding options in all panels and counter tables.</li><li>• Separation wall between each co-participant for ensuring privacy (Half/full)</li><li>• Shelves &amp; spotlight</li><li>• Dustbin</li></ul>

4	<p><b>Spices Board's area</b></p> <p>The stall must have a well decorated reception area. The area of Spices Board must have the following facilities.</p> <ul style="list-style-type: none"> <li>• VIP seating arrangement [Sofa set ( one 3 seater + one 2 seater )]</li> <li>• Discussion area with 5 round tables and 20 chairs</li> <li>• Coffee table</li> <li>• LED TV</li> <li>• Water dispenser- 2 Nos.</li> <li>• Tea/coffee vending machine with ingredients</li> <li>• Reception counter</li> <li>• Glass Showcase for display of spice products.</li> <li>• Store room</li> <li>• Brochure stand</li> <li>• Full size branding in common area.</li> </ul>
5	Stall fabricator should ensure sufficient number of staff in the event venue from the beginning to the end of the exhibition for managing the stall and extending any sort of assistance as directed by the Spice Board's designated staff for the particular event.
6	After receiving the work order, stall designer must immediately contact the exhibition organizer for initiating the fabrication works. The stall designer should be fully aware of all construction and decoration regulations at Bharat Mandapam, Pragati Maidan, New Delhi, India.
7	It is the sole responsibility of the selected stall designer to fill up the mandatory forms & obtain approval for design from the organizer before the commencement of erection. The stall fabrication should be in compliance with the organizer guidelines for stand construction. It will be the responsibility of the stall fabricator to remit any security deposit demanded by the organizer in connection with the event.
8	The stall designer shall use prefabricated structures to prevent delays in stall completion and to avoid causing inconvenience to other exhibitors. All electrical installations and wiring must be carried out by a licensed electrician. Utmost care should be taken to refrain from causing any deformation or damage to the exhibition hall during the set-up of the stall.
9	The electricity payment shall be remitted by the stall designer and later get it reimbursed on submission of proper tax invoice.

### ESSENTIAL ELIGIBILITY CRITERIA

The applicant must be empaneled/ enlisted through CPP Portal for designing & fabricating the stall of Spices Board in the International & Domestic trade fairs for the period of two years starting from 2025-26.

### GENERAL TERMS AND CONDITIONS

1. The terms and conditions of the EOI for empanelment of stall fabricators will be applicable here as well and the agencies are liable to adhere to the same.
2. The agency should not be involved in any litigation that may impact or compromise the delivery of services as required.
3. The Agency shall not be allowed to transfer, assign, pledge or sub-contract its rights and liabilities under this contract to any other Company/Firm/Agency/Contractor without the prior written consent of the Board.

4. Spices Board reserves the right to reject any application without assigning any reason thereof.
5. Spice Board will have the right to increase or decrease the number of co participant booths during the time of Award of Contract & the fabrication should be according to the final decision of Board
6. Spices Board does not make advance payments. Any request of Advance payment will be rejected summarily.
7. All communications from Spices Board regarding this tender will be from the above given email id and contact number. For any query please contact in the above email and telephone only.

## **SUBMISSION OF BID**

The interested agency should submit the bid with following details:

- a) Detailed design of the stall with dimensions. A layout with grid lines with proper demarcation of components of the stall (viz, co participant booths, Spices board area, store room, reception etc.) & the front, back, top, and side views of the stall in a single PDF including the dimensions should be uploaded in the CPP Portal. In addition to the same, if space permits, the bidder can upload supporting documents highlighting the aesthetics & technical sides of the design. No financial part shall be mentioned in the design or anywhere in the technical bid.
- b) Financial quote may be submitted in the particular field of CPP portal. The BOQ excel sheet in the prescribed format shall be filled and uploaded (only in the financial bid).

A bidder can submit only one proposal. If the Bidder submits more than one proposal, such proposals shall be disqualified. Bids received after the closing date and time will be rejected without any further communication on the matter.

All documents mentioned in the bid submission should be duly signed and uploaded on the central public procurement portal (<https://eprocure.gov.in/eprocure/app>) with in the stipulated time.

## SELECTION PROCEDURE

- The selection criteria will be QCBS with a weight age of 50% for the technical proposal and 50% for financial proposal. The Quotes will be evaluated by selection committee of the Board as given below:
  - **Quality of the design:** (quality & strength of the conceptualized design, aesthetics, optimum space utilization, innovation & creativity)- 50 %
  - **Cost** (Inclusive of taxes applicable)-50%
- The minimum qualifying mark for technical bid shall be 70 out of maximum 100. The bidders who score 70 mark and above would be considered as technically responsive and the rest would be considered as technically nonresponsive and would be dropped from the list. Financial proposals are then opened for only eligible and technically responsive bidders and other financial offers would remain unopened.
