**NOTICE INVITING TENDER**

Flavourit Spices Trading Ltd (FSTL) an enterprise of Spices Board, Kochi, invites competitive and sealed quotations from technically competent firms for performing works related to **Renovation and interior works of spice outlet at Myladumpara** which is being established by FSTL near Spice Research Station Myladumpara, Idukki District of Kerala. Interested firms should submit their quotations latest by 15/06/2020 to **Director, M/s. FSTL, Spices Board, Sugandha Bhavan, N H By-pass, P.B. No.2277, Cochin-682025.** with superscription **“Tender for interior decoration of spice outlet at Myladumpara”** The details regarding scope of work, terms and conditions are given below:-

**1.1 Eligibility Criteria**

1. The bidder should have a valid registration (Proprietorship, Partnership, Private Limited Company, etc)
2. The bidder should have experience in having carried out similar works undertaken during the preceding two years.
3. For item 1 & 2 necessary proof to be produced by the bidder.

**1.2 Scope of Works**

The scope of the works includes:-

- 1) Truss work on the proposed building – To be made with aluminum sheets of required thickness with necessary support made of GI pipe/ steel anclair
- 2) Flooring- Vitrified tile flooring of good quality
- 3) Display racks – Made with ply wood ( marine) of required thickness ,with steel frames with glass racks
- 4) Electrical fittings with 1 sq mm V guard make for light points raceway, cables, switches ,fittings etc.
- 5) Doors and windows made with aluminum frame work with glass
- 6) Civil work, wherever required
- 7) Painting , Asian premium acrylic emulsion on wall
- 8) Demolition ,wherever required.

The bidder shall furnish the following:-

- (i) Layout of the out let in the proposed Building
- (ii) Technical Specification of the material used for roof/shelf/floor/Partition including doors, if needed
- (iii) Bill of Quantity {BOQ} and Price Schedule for both Supply and installation
- (iv) Terms & Conditions and exclusions, if any.

- 1.3. It is advised that the interested firm may visit the proposed building /site at their own cost for inspection before submitting the tender
- 1.4. Submission of a tender by a firm implies that they have read this notice and has made themselves aware of the scope and specifications of the work to be done.
- 1.5 EMD :-Earnest Money Deposit is Rs 15,000/- (Rupees Fifteen thousand only). It shall be drawn from Nationalized or Banks approved by the Government of India in the form of crossed demand draft in favour of Flavourit Spices Trading Ltd, payable at Ernakulam. EMD of the unsuccessful tenders will be refunded without any interest on finalization and award of works to the successful Bidder.

EMD deposited will be forfeited under the following conditions,

- i) if a bidder withdraws his bid during the process of evaluation for its finalization.
- ii) if the successful bidder fails to execute agreement within the time limit.

- 1.6 Performance guarantee/Security deposit:- The successful tenderer shall deposit an amount equal to 10 % of tendered and accepted value of the work as performance guarantee/security deposit as Demand Draft/ Bankers Cheque/Bank Guarantee from a scheduled bank in favor of 'Flavourit Spices Trading Limited' payable at Ernakulam, out of which 5% shall be refunded after one year and the remaining 5% immediately after expiry of the defect liability period (two years) from the date of successful completion of the work. The EMD of the successful bidder will be refunded after remittance of the performance guarantee/security deposit and execution of the agreement.
